**Commission Meeting Open Session Minutes** September 15, 2021

The Maryland-National Capital Park and Planning Commission met via videoconference with the Chair initiating the meeting at the County Administration Building in Upper Marlboro, Maryland. The meeting was broadcast by the Montgomery Planning Department.

#### ITEM 5 ACTION AND PRESENTATION ITEMS (taken out of order)

j) Regional COVID Outlook Presentation, speaker Prince George's County Health Officer Dr. Ernest L. Carter, MD, PhD

Dr. Carter provided a snapshot of the regional COVID outlook for awareness and planning. He also shared his medical opinion on stopping the spread of the virus and some of the obstacles the region must navigate in order to do so.

Highlights included:

- Ongoing COVID cases among unvaccinated adults and children are not allowing the virus to die out.
- Vaccination is the best way to keep the spread down and to keep mutations to a minimum.
- Delta is two times as contagious as the original variant.
- 70% of the region's population who are 12 years and older are vaccinated. Need 88-90% vaccinated.
- It is clear the vaccine is safe and effective. It saves lives, it saves lives of family members.

Chair Hewlett noted the differences in COVID statistics between Montgomery and Prince George's County. Dr. Carter discussed the increase in positivity cases and hospital capacity. Commissioner Doerner noted from the M-NCPPC employee survey on COVID, that those employees who were not vaccinated but intended eventually to get it said they preferred to wait to see their primary physician to get the shots. He asked if there was a reason they shouldn't go wherever they need? Dr. Carter replied it will be the same shot wherever they can get it, and they should get it from wherever they can. He added there is hesitance to distribute the shot to smaller private practices, because of the limited shelf life of the vaccine. Larger practices will more likely have a supply.

Commissioner Cichy asked about the vaccination status for hospital workers, and Dr. Carter confirmed, it is required in Prince George's County. Commissioner Geraldo asked who should be getting a booster and Dr. Carter replied they are approved for immune-compromised people adding studies are continuing to determine need/efficacy of boosters for others. Chair Hewlett asked if a person has had COVID, they sometimes say they are now immune. She asked if they should get the vaccine regardless. Dr. Carter replied they should, adding the immune system will have a better response than someone who has never had it, but a shot will help protect more effectively.

Chair Hewlett thanked Dr. Carter on behalf of the Commission for sharing his knowledge and information.

Chair Hewlett state the M-NCPPC has celebrated and honored Juneteenth for decades and is thankful that the agency is adopting this Resolution today.

c) <u>Resolution 21-23 Amendment to the Fund Balance Policy (Zimmerman)</u> No discussion.

ACTION: Motion of Commissioner Geraldo to adopt Resolution 21-23 Seconded by Commissioner Doerner 7 approved the motion

d) CAS Cost Allocation (Kroll)

Corporate Budget Manager Kroll mentioned this year's allocation to fund the Central Administrative Services will shift \$135,000 from Montgomery to Prince George's County.

ACTION: Motion of Commissioner Geraldo to approve the item Seconded by Commissioner Doerner 7 approved the motion

e) Addition to Benefit Plan (Hearing Aids) (modified item) (Spencer/McDonald)

Chair Hewlett stated this topic has been forwarded to the Commission after discussion during Executive Committee. Executive Director Chiang-Smith requested approval to add a health benefit for hearing aids. She said the cost to the agency would be \$60,000 for a 50% cost split between the M-NCPPC and the employee; while covering at 80% would cost \$62,000. Due to the minimal increase, she noted the Executive Committee recommended adding the benefit with the M-NCPPC taking 80% of the benefit premium. The benefit itself would make a major difference for employees and their families and improve their quality of life.

Chair Hewlett asked if the benefit was extended to retirees. Corporate Human Resources Director Spencer confirmed. Commissioner Geraldo said recently there has been the introduction of less expensive hearing aids and asked if there would be any requirement to go to those if they would work. Spencer replied that would be a decision between the employee and their doctor.

ACTION: Motion of Commissioner Geraldo to approve the benefit addition. Seconded by Commissioner Doerner 7 approved the motion

f) <u>Sick Leave Bank Program Amendments (Chiang-Smith/Spencer/Beckham)</u> Executive Director Chiang-Smith said this proposal came from Montgomery Planning staff, who worked with the agency's Corporate Policy and Human Resources staff to provide an extended family medical leave benefit. She clarified the amendment is currently just for nonrepresented employees, noting the program amendments are still being negotiated with the unions. Acting Corporate Budget and Management Operations Manager Coburn described the changes to the policy, stating the surplus balance of the existing sick leave bank program

will fund the changes in the short-term, before moving to having a dedicated fund for the long-term. He noted both Department Heads and Executive Committee supported the amendments.

Commissioner Doerner thanked staff who worked on the amendments, adding how important a benefit this is for families.

ACTION: Motion of Commissioner Geraldo to approve the program amendment. Seconded by Commissioner Doerner 7 approved the motion

- Audit Committee Report (Verma) Commissioner Verma provided an overview of the Audit Committee Annual Report, distributed as a late delivery item.

Chair Hewlett congratulated Inspector General Kenny, on her re-appointment to the position. She thanked the Audit Committee members and shared her appreciation for the work they do.

k) Vaccination Policy/Return to Work Policy/M-NCPPC COVID Trends (Chiang-Smith/Spencer/Beckham)

Executive Director Chiang-Smith prefaced the item by re-iterating some of the statistics that Dr. Carter had referenced earlier in the meeting on positivity rates in the counties, adding in the winter, the rates are expected to get higher. She said Risk Management staff continue to track cases and analyze trends. She discussed findings from the employee vaccination survey and shared the main reasons cited by employees for not getting vaccinated related to questions regarding the efficacy and safety of the vaccine.

An agency-wide work group has been meeting regularly to discuss policy and guidance on how the M-NCPPC should address the question of requiring vaccines for all employees who are returning to the worksite while evaluating the incoming data of local state and national trends. The group consists of senior leadership from all departments across the agency, plus Policy, HR, Safety, and Legal staff. The team has developed a policy mandating the vaccine for all non-represented employees, with exemptions for bona fide religious or medical reasons. The Fraternal Order of Police Collective bargaining unit has agreed to the proposed policy. The policy is still under negotiation with the Municipal and County Government Employees' Organization (MCGEO) bargaining unit.

Mr. Beckham provided background on the proposed policy and noted it was supported by Department Heads and Executive Committee. He also reviewed a flowchart that laid out the process with results for different variables regarding an employee's vaccination status. The flowchart also laid out the process for accommodation decisions. Non-represented



employees and park police will be required to be vaccinated by October 31. The draft policy provides the relevant information, including a timeline to assist employees to know by when to start and follow through with the vaccination process. He also noted all information submitted will be kept in a secure file, accessible by limited staff.

Commissioner Doerner thanked the team, saying the set-up and process for submitting vaccination confirmation was easy. He suggested providing a word version of the form, as opposed to PDF, for employees who may not have a scanner or the appropriate software. He also suggested an amendment to the flowchart, noting he did not want Department Heads solely to make an accommodation decision and suggested amending the language to reflect "Department Heads will work with HR to make a decision". Commissioner Geraldo agreed.

Executive Director Chiang-Smith said the IT group was developing an app to allow employees to submit the information online. The information would go to a secure server, and allow employees to sidestep filling out the form. She agreed to examine the text to reflect Commissioner Doerner's suggestion and reiterated the desire to work with people while keeping our workplace safe. General Counsel Gardner noted any disciplinary measure has to be coordinated with HR. He added any disciplinary decisions will be made on a caseby-case basis and will be transparent, per the Merit Rules.

Commission Geraldo asked if the mandate would apply to contractors. General Counsel Gardner replied that the Legal department is prioritizing and examining that. Vice-Chair Anderson noted the policy also needed to sort out directives for members of the public who may want to attend a public meeting. They should be required to show evidence they've been vaccinated. Commissioner Doerner agreed. Vice-Chair Anderson also said the two sides of the Commission will need some flexibility separately, although he supported taking a hard line.

Chair Hewlett called this a bold, but necessary step, for the greater good. The intent is to make sure everyone is safe.

ACTION: Motion of Commissioner Geraldo to approve the Policy with amended language as discussed Seconded by Commissioner Doerner 7 approved the motion

Discussion	3a. Sustainability Plan Deadline Extension (Aparicio/Nolan)	
	Ms. Aparicio introduced the Sustainability Committee members. She said the Sustainability Committee requested approval of the Executive Committee for an extension of the current Sustainability Plan throught FY 2022 to allow time to fold in details from both counties' Climate Action Plans, of which Prince George's County only recently released its draft. Additionally, the Sustainability Committee will work to propose changes to Practice 6-40, M-NCPPC Sustainability Standards, to be in sync with both counties' Climate Action Plans. She also noted Department Heads, during their presentation at their meeting last week, suggested developing a sustainability goal of a zero-carbon footprint for M-NCPPC facilities for the agency's centennial in 2027.	
	Executive Director Chiang-Smith said the Department Heads received a more comprehensive briefing last week, which is where the idea of marking sustainability goals for the 2027 M-NCPPC centennial came from. The goals can address environmental concerns, particularly in supporting equity in impacted neighborhoods. She said the committee would need to examine how long potential goals would take, the cost, what the agency needs to do to accomplish it. Meeting the goals the agency sets would be a great statement and showcase how the M-NCPPC is a leader on the topic.	
	The proposed changes the Sustainability Standards Practice (6-40) and FY 2023 – FY 2024 Sustainability Plan would be presented in early 2022, to accommodate input from the Prince George's County Climate Change Plan. Vice-Chair Anderson requested a side-by-side comparison of the two counties' plans. Mr. Nolan agreed, saying if one county has a higher standard than the other, then the M-NCPPC should model its plan off of the more stringent of the two counties.	
	The Executive Committee supported the extension, and also supported the goal statement for the Centennial. Vice-Chair Anderson added the need for further conversations on what the goals should be to ensure they are attainable and realistic. There are ways to refine the approach, how to measure it to meet environmental goals and reflect what the agency already does. He suggested the scope might be broadened to track the environmental contribution of the agency's stormwater management plans.

	Executive Director Chiang-Smith said the department heads asked the Sustainability Committee to return with those metrics in a few months with the report.
	Vice-Chair Anderson also supported the revisions to the practice and suggested specifically including some of the goals to be developed. Executive Director Chiang-Smith said Acting CPMO Director Beckham can assist in amending/updating the policy.
ACTION/follow-up	Vice-Chair Anderson moved to accommodate the extension. Chair Hewlett seconded. Motion passed unanimously.
Discussion	3b. Stand-by Compensation Policy (Beckham)
	Mr. Beckham requested Executive Committee support to make permanent this program, which has been in place in a provisional format for two years. Policy staff would work with the Executive Director to update the procedures, including addressing in the policy the differences between the two counties.
	Chair Anderson voiced concern over the disparity between the hours required by each county for employees on standby. The Chairs requested more input from the Parks Department Directors before a final decision.
ACTION/Follow-up	Acting CPMO Director Beckham will brief the Parks Directors, who will then provide input to the Chairs for a decision. Item tabled.

#### ITEM 5 REPORT OF THE ADMINISTRATOR

Andrea L. Rose presented the Administrator's Report dated July 1, 2021

The Board agreed to move the September 7, 2021 Board meeting to September 14, 2021 due to the holiday weekend.

Andrea Rose provided an update on the progress of the new pension administration software project, PensionGold. The final phase, document imaging, is underway. The imaging sub-contractor is expected to be onsite imaging all member files at the beginning of August 2021. The project is expected to take 3-4 months.

The Member Direct portal is ready for delivery; however, the Commission's IT Department had concerns regarding use of a single server for both Member Direct and PensionGold and recommended a separate dedicated webserver to provide separation and security from the main database. ERS staff agreed with the Commission's IT Department. This will result in additional hosting fees plus a one-time set-up fee of \$3,320. There are no concerns or adjustments required for the FY2022 Operating Budget. The ERS plans to rollout Member Direct to its members in 2022.

Staff recommend the Board approve a separate server for Member Direct and additional hosting fees as follows:

- Year 3 1/1/22 to 12/31/22 \$6,679 + one-time set up fee of \$3,320
- Year 4 1/1/23 to 12/31/23 \$7,013
- Year 5 1/1/24 to 12/31/24 \$7,013
- Year 6 1/1/25 to 12/31/25 \$7,364
- Year 7 1/1/26 to 12/31/26 \$7,732

The ERS will be working with the Groom Law Group regarding the rules and regulations surrounding eDelivery via Member Direct with analysis of the ERS' cyber insurance policy to ensure adequate coverage given the new feature.

**<u>ACTION</u>**: VICE CHAIRMAN CICHY made a motion, seconded by MS. MILLAR to approve a separate server for Member Direct and the additional hosting fee schedule as recommended by staff. The motion PASSED unanimously (10-0). (Motion #21-37)

#### Administration & Personnel Oversight Committee – Report of June 15, 2021

Committee Chairman, Joseph C. Zimmerman, presented a Plan Document Restatement dated August 1, 2021 and a memorandum dated June 8, 2021 from the Groom Law Group that reviews the changes made in the Restatement. The Personnel Committee recommends the Board approve the Restatement.

**ACTION:** VICE CHAIRMAN CICHY made a motion, seconded by MS. CHIANG-SMITH to approve the Plan Document Restatement dated August 1, 2021. The motion PASSED unanimously (10-0). (Motion #21-38)

The Personnel Committee reviewed a revision to the ERS' Recognition Program Policy (the "Policy") that includes an exception to the maximum cash award.

The Policy currently has a maximum cash award of \$500 which does not adequately compensate employees for their efforts during these unusual times. It is because of the incredible efforts of the project team that the ERS did not receive monetary penalties during implementation of the new pension software administration system. The revision to the Policy permits the Administrator to approve up to \$500 per employee each fiscal year; the Personnel Committee to approve up to \$1,000 per employee each fiscal year; and the Board to approve amounts in excess of \$1,000, if appropriate.

**ACTION:** MR. ZIMMERMAN made a motion, seconded by VICE CHAIRMAN CICHY to approve the revised Recognition Program Policy. The motion PASSED unanimously (10-0). (Motion #21-39)

#### ITEM 7 CLOSED SESSION

#### **RESOLUTION**

WHEREAS, The Maryland-National Capital Park and Planning Commission ("Commission") is authorized under the Annotated Code of Maryland, Land Use §17-205 to transfer any land held by it and deemed by the Commission not to be needed for park purposes or other authorized purposes; and

WHEREAS, Prince George's County Department of Public Works and Transportation ("DPW&T") and the Commission have created a land bank. In July 2001, DPW&T deeded to the Commission a 28.3682 acre parcel as the "deposit" into the land bank, with the understanding that in the future DPW&T would ask the Commission to convey to DPW&T a number of small pieces of Commission property for DPW&T road improvement projects, and that the acreage of such small pieces would be "debited" against the initial "deposit." The land bank has a current "balance" of 24.14 acres; and

WHEREAS, the Commission owns certain property known as Piscataway Creek Stream Valley Park consisting of Parcel 63: Election District 11, Tax Act. #1137983, Liber 0000 folio 000 (23.58  $\pm$  acres); Parcel 113: Election District 09, Tax Act. #0941518, Liber 04746 folio 475 (0.08  $\pm$  acres); Parcel 142: Election District 11, Tax Act. #1160449, Liber 03786 folio 527 (22.26  $\pm$  acres); for a total of 45.92  $\pm$  acres located in Clinton, and further identified as Tax Map 134, Grid C-1, C-2; and D-2, hereinafter collectively referred to as "Piscataway Creek Stream Valley Park"; and

**WHEREAS,** to replace Brandywine Road bridge P-0495 over Piscataway Creek, DPW &T has requested that the Commission convey to it in fee simple 59,906  $\pm$  square feet (1.29  $\pm$  acres) of Piscataway Creek Stream Valley Park as more particularly shown on DPW&T Plat Nos. 1805 and 1806.

**NOW, THEREFORE BE IT RESOLVED**, that the Prince George's County Planning Board approves the conveyance of such 59,906  $\pm$  square feet (1.29  $\pm$  acres) to DPW&T, subject to final approval by the Full Commission, and agrees that the land bank will be debited by such amount, leaving a new land bank balance of 22.85 acres.

**BE IT FURTHER RESOLVED,** that, in connection with the transactions contemplated herein, the Executive Director is authorized to execute and deliver, on behalf of the Commission, any and all such certificates, documents, and/or instruments, and to do or cause to be done, any and all such acts, as the Executive Director deems necessary or appropriate to make effective or to implement the intended purposes of the foregoing resolution, without limitation, and the taking of such actions shall be deemed conclusively to be authorized hereby.



Date: October 20, 2021

As you are aware from previous briefings of the full Commission on this project, the Federal Highway Administration (FHWA), as the Lead Federal Agency, and the Maryland Department of Transportation State Highway Administration (MDOT SHA), as the Local Project Sponsor, have conducted a Managed Lanes Study (MLS) for the I-495 & I-270 highway systems. Since March 16, 2018, the MLS has evaluated a range of alternatives within the specific study scope of I-495 from south of the American Legion Bridge in Fairfax County, Virginia to east of the Woodrow Wilson Bridge and on I-270 from I-495 to I-370, a nearly 50-mile long study area.

On May 12, 2021, MDOT SHA announced their decision to mirror the path established by the Maryland Board of Public Works in the procurement process and proceed with the National Environmental Policy Act (NEPA) study for Phase 1 South only, leaving the other two Beltway segments (topside through Silver Spring and I-95 to Woodrow Wilson Bridge) to an undetermined future phase. MDOT SHA further announced that they would prepare a Supplemental Draft Environmental Impact Statement (SDEIS) to formalize this decision and conduct an updated and revised analysis. The SDEIS was released to the public on October 1, 2021.

The immediate effect of a reduction of the study area is that the segments of the Beltway located in Prince George's County are no longer part of this MLS NEPA process. As a result, we recommend that the Commission follows the standard approval procedure for master plans applicable to a single county. For purposes of reviewing and approving staff comments and MDOT SHA requests for concurrence on the MLS moving forward, the Montgomery County Planning Board would perform this function, with final comments and decisions on concurrence requests placed on the next available full Commission meeting's consent agenda. This process is consistent with Commission Practice 1-10 and ensures that the full Commission's records regarding the agency's responses and decision-making on the MLS will be complete and transparent.

Additionally, Carol Rubin, the former Montgomery Planning MLS Special Projects Manager, retired on October 1, 2021. I have been asked to coordinate MLS review and responses from Montgomery Planning and Montgomery Parks with the help of technical staff in both departments, so I will be the point of contact as we move forward in the NEPA process.

### For Informational Only

The Commission is being informed of changes to the Agency's life insurance benefits to increase employee enrollment. No action is requested. This is for informational purposes.

### **Background**

Some employees do not think about the financial consequences their families would face in the event of their death. For most people, savings alone would not be enough to pay the bills if an income was suddenly lost. The Commission's life insurance programs can help. However, over the past few years we have had a number of employees pass away suddenly, without even basic life insurance coverage.

The current life insurance plan includes the following:

- All plans are voluntary.
- Enrollment is not automatic; employees must complete an enrollment form for each plan.
- Merit employees can enroll in the Basic, Spouse/Dependent and Supplemental Life Insurance Plans.
- Employees must enroll in the Basic Life Insurance Plan as a prerequisite to enrolling in either the Spouse/Dependent Plan or the Supplement Life Insurance Plan.
- Employees are automatically enrolled in Accidental Death and Dismemberment (AD&D) when Basic Life is elected. It cannot be elected as a stand-alone benefit.
- Both Basic and AD&D are paid out in the event of a work related or nonwork-related accident.
- Each plan provides death benefit coverage during a fixed period or "term", which is the length of your employment at the Commission. Term life insurance has no cash or surrender value.
- Upon separation, life insurance may be converted to an individual policy.

### **Enrollment**

A recent review of the enrollment in basic life insurance showed that approximately 30% of eligible employees are not enrolled, despite the low cost. Eligible Merit System employees may enroll in the life insurance plans within forty-five (45) calendar days of hire or attaining Merit status. If the employee does not enroll within the 45 days or is requesting an amount above guaranteed issue for supplemental life, an Evidence of Insurability (EOI) form must be completed by the employee. The EOI form asks health related questions, which is then underwritten by the insurance carrier for approval or denial. After the initial eligibility period, eligible employees may enroll at any time during the year and is not restricted to only during the annual open enrollment period which occurs during the fall of each year. All enrollments after the initial eligibility period require completion of EOI regardless of the amount or type of coverage elected.

As mentioned above, enrollment in life insurance is not part of the annual open enrollment period. Employees may enroll, make changes, or cancel coverage anytime during the year. To address the low enrollment, in 2018 the agency negotiated with the insurance carrier a one-time guaranteed issue period for employees who were not enrolled including those who may have been declined previously. The special enrollment period also allowed increases to existing coverage up to the normal guaranteed issue amounts. This effort, during the open enrollment season in the fall of 2018, did not result in a significant increase in enrollment.

### Automatic Enrollment

To increase enrollment and provide a valuable benefit to all eligible employees, DHRM will implement automatic enrollment of employees in basic life insurance, effective January 1, 2022. The agency has a precedent for mandatory/automatic enrollment. Effective 8/1/1982, enrollment in the Long-Term Disability Plan became mandatory with automatic enrollment and a cost share of 20% paid by the employee.

Local governments and agencies around the region that compete for our talent/ employees offer full basic life insurance coverage, most notably, WSSC, Prince George's County, Howard County, Anne Arundel County, the State of Virginia, Fairfax County, Arlington County and Alexandria County. Montgomery County pays 75%. The chart below shows the rates paid by several local jurisdictions and the federal government:

The current budget for the cost of providing Basic Life Insurance and AD&D with the agency paying 80% and the employee paying 20% of the premium, is \$402,266. *If the Commission were to pay 100% for Basic and AD&D coverage for all eligible employees, the total cost would be \$659,939, an additional cost of \$257,675, annually.* The estimated total annual <u>additional cost</u> per department to fully fund basic life insurance for Merit system employees is\*:

The Executive Committee and Department Heads support the automatic enrollment of employees in the Basic Life Insurance and AD&D with the option to opt out. The agency will continue to pay 80% and the employee will pay 20% of the premium. This will be effective January 1, 2022.

The Fraternal Order of Police, Lodge 30 (FOP) and The Municipal and County Government Employees Organization (MCGEO) unions have signed Memorandums of Understanding agreeing to automatic enrollment with the option to opt out.

The insurance carrier has confirmed that the current uninsured employees will be covered without evidence of insurability and without an increase in the current rates but only for this current open season. Should an employee opt out and then wish to re-apply, they would have to provide evidence of insurability.




