Executive Director Barney noted that the changes had already been described to the Commission and discussed during its September 2018 meeting, and this Resolution was simply to adopt the language.

a) <u>I-495/I-270 Managed Lanes Update (Rubin/Borden)</u>

Special Project Manager Carol Rubin introduced Principal Counsel Debra Borden, Transportation Engineer Stephen Aldrich and Planning Supervisor Tom Masog. Ms. Rubin discussed the background and timeline of the project, sharing that it had an extremely aggressive schedule as set forth in the memorandum to the Commission dated October 11, 2018.

Ms. Rubin stated staff will make certain the State Highway Administration (SHA) remains cognizant of the M-NCPPC's role as both a regulatory agency and a steward of natural and cultural resources in Montgomery and Prince George's Counties. All four operating departments and the Legal Department are working closely together on this project. Rubin praised the staff from all departments participating in this project.

Ms. Rubin explained that the Inter-Agency Work Group (IAWG) monthly meetings held by the SHA, with Lead, Sponsoring, Cooperating and Participating agencies throughout Maryland, allow involved agencies to collaborate, identify and resolve environmental issues in an open and frank discussion among themselves. Since MDOT SHA considers these meetings part of their deliberative process, the discussions and materials presented therein remain confidential. During the November 14 IAWG meeting, SHA will present their recommended Alternatives Retained for Detailed Study (ARDS) to the participating agencies. Agencies owe their comments to the SHA by December 12. The SHA is looking for agency concurrence by January 23, after which it will release the ARDS selection to the public. Therefore, staff sought guidance from the Commissioners based on information that is publicly available.

Ms. Rubin reported that The National Capital Planning Commission encouraged the SHA to consider retaining sustainable transportation options and to limit the impact to Capper-Crampton land.

Ms. Rubin and the team presented their recommendations on which alternatives should be abandoned and which should be advanced. Ms. Rubin stressed they were *not* currently

asking Commissioners to consider whether, and to what a degree, there will be impact on parkland and other environmental and cultural resources. This analysis focuses on function over form and to influence SHA's decision-making process in ARDS selection. The team reviewed the alternatives under the view of the National Environmental Policy Act (NEPA) and best practices, and based on those factors, as reflected in the attached Power Point presentation, eliminated eleven alternatives 3, 5, 6, 7, 8, 9, 10 without modification, 11, 12a, 12b, and 15), and recommended advancing the following alternatives (1, 2, 4, 10 as modified, 13A, 13B, and 14A-C with more specific detail).

Ms. Borden noted one of the issues with selecting an option is that the transit system being studied is so large and so varied. Multiple options might be considered for the project, as different alternatives may work better in certain segments, depending upon current infrastructure.

Commissioner Doerner shared concerns that it appeared the SHA had not examined immediate or long-term environmental impacts brought up by the Purpose & Needs (P&N) Statement. Ms. Rubin stated staff at both Parks, and Parks and Recreation departments are looking at this closely. Commissioner Doerner recommended that Planning staff should be included in the process. Mr. Aldridge indicated that Planning staff will be included and will reiterate some of the critical environmental impact issues identified in the P&N Statement when making their ARDS recommendation. Ms. Rubin stressed that a greater environmental impact study would be made on the ARDS after they are selected by SHA. Mr. Aldridge added they will not want to constrain the P3 contractor from innovating transportation alternatives such as vertical separation, tunnels, bridges, etc. and the P3 contractor will be required to address environmental impact concerns.

Chair Anderson inquired how anyone would know the environmental impact of a project without knowing the footprint of the project as laid out by the P3 contractor. While the geometric constraint will affect the P3 contractor's options to innovate, in some ways the solution could be worse than the problem it solves. Moreover, how will the environmental impacts be known or anticipated before the P3 contractor even has an opportunity to submit design plans? Ms. Rubin responded that staff has requested strong and broad language in our P&N comments to ensure the P3 contractor addresses those impacts.

Commissioner Cichy agreed, stating the environmental impact should be defined within the relationship with the P3, the review, and participation in the process. Ms. Rubin shared staff will push the environmental impact mitigation as an absolute requirement. She added that Department Heads would be meeting in mid-November with the Maryland Transportation Secretary and the SHA Administrator to discuss these issues in relation to the alternatives.

Commissioners raised various concerns in relation to specific roadways and interchanges. Ms. Borden stated staff included the concerns of Commissioners in their comments submitted to the SHA. Staff listed upcoming and proposed projects in both counties for the purpose of letting the SHA consider helping integrate these other projects with this one, through funding, design tie-in, or other efforts to make sure these projects are aligned with the managed lanes project. Mr. Aldridge added that a combination of alternatives may work depending upon existing conditions.

Commissioner Dreyfuss asked what input Commissioners have, if they disagreed with the recommendation of staff as to whether an alternative should be advanced to the ARDS level. Ms. Rubin suggested contacting her and Ms. Borden after the meeting to address concerns.

Ms. Rubin said they will continue to meet and work, with the IAWG. On Jan 23, SHA wants concurrence or concurrence with comment on the ARDS prior to public release. She reiterated that discussing the alternatives in detail during the Commission meeting takes the discussion public before the SHA is ready to do so, and therefore asked if the comments collected during the Commission meeting could be used to inform the recommendations staff will present to the SHA on the ARDS.

Bradley Baker reported on the fund's performance for the quarter ending June 30, 2018. The ERS' total fund return was 1.09% (net of fees) for the quarter, outperforming the actual policy index return of 0.68%. The ERS fund return was 7.94% for the one-year ended, 7.26% for the three-years ended, and 7.41% for the five-years ended June 30, 2018 versus the actual policy index which returned 7.16%, 6.38% and 6.90%, respectively. The total market value through June 30, 2018 was \$922.0 million.

MS. GOGOL left the meeting at 12:00 p.m.

Mr. Baker presented the Fixed Income Education Session Update which provided an analysis related to the ERS' fixed income portfolio structure and optimization analysis. Wilshire concluded the ERS' current fixed income portfolio is well diversified and efficient given the current exposure to multiple fixed income segments globally yet it suggests the portfolio could benefit from implementing a dedicated Emerging Market Debt allocation and/or increasing the allocation to Bank/Senior Loans. The Board referred this to the Investment Monitoring Group for further review and recommendation.

The Board of Trustees meeting of September 11, 2018 adjourned at 12:32 p.m.

Patricia Barney presented amendments to the Employees' Retirement System Plan Document, which reflect recent plan design changes for Plans B and E adopted by the Commission at its July 18, 2018 and September 26, 2018 meetings under Commission Resolutions 18-21, 18-31 and 18-26.

MS. MILLAR joined the meeting via teleconference at 10:03 a.m.

The amendments for Plan B modify the spousal benefits for existing employees and future employees who, as a result of prior employment, re-enter Plan B and are effective July 1, 2018. They are as follows:

- Non-vested Participants are provided a choice of a lifetime annuity equal to 25% of final annual base pay, or a lump sum of 50% of average annual earnings plus contributions and interest;
- Vested Participants are provided a choice of a lifetime annuity equal to 25% of final annual base pay, or a benefit paid had the deceased refired and selected a 100% joint and survivor benefit;
- Spouses are provided 60 calendar days from the date of notification to make an election; otherwise, the spouse receives the applicable default benefit; and
- Clarifying language provides these benefits to certain employees who do not make active contributions to the ERS.

MR. BROWN left the meeting at 10:05 a.m.

The amendments for Plan E modify the spousal benefits for existing employees hired on or before September 30, 2018 and new employees hired on or after October 1, 2018. They are as follows:

- Non-vested Participants hired on or before September 30, 2018 are provided a choice of a lifetime annuity equal to 25% of final annual base pay, or a lump sum of 50% of average annual earnings plus contributions and interest;
- Non-vested Participants hired on or after October 1, 2018 are provided a lump sum of 50% of average annual earnings plus contributions and interest;
- Vested Participants are provided a lifetime annuity based on the benefit paid had the deceased retired and selected a 100% joint and survivor benefit;
- Spouses are provided 60 calendar days from the date of notification to make an election; otherwise, the spouse receives the applicable default benefit; and
- Clarifying language provides these benefits to certain employees who do not make active contributions to the ERS.

The Commission also approved extending the same provisions for the purchase of credited service to non-represented employees, that are currently offered to represented employees, participating in Plans B and E effective October 1, 2018. Ms. Barney highlighted these amendments in the Plan Document. They are as follows:

- Effective October 1, 2018, non-represented employees will be allowed a one-time option to purchase up to five (5) years of credited service for certain qualifying time on the same terms and conditions as the MCGEO-represented employees with two exceptions as follows:
 - Non-represented employees hired or appointed prior to January 1, 2019 will be able to exercise the option to purchase credited service one time either during the period between January 15, 2019 February 14, 2019 or during the window which is at least 31 but not more than 60 days immediately prior to retirement; and
 - Non-represented employees (re) hired or appointed on or after January 1, 2019, who enter Plan E or re-enter Plan B, will be able to exercise the option to purchase credited service one time either within 45 days of (re) hire or during the window which is at least 31 but not more than 60 days immediately prior to retirement.
- Non-represented employees who exercise the option to purchase credited service are required to pay to the ERS 100% of the full cost of the credited service as determined by the actuaries in either a lump sum or in equal payments not to exceed five (5) years.

The amended Plan Document was drafted and reviewed by M-NCPPC Legal Department's LaTonya Reynolds and the Groom Law Group's David Levine and Kimberly Boberg and they recommend approval of the plan amendments.

<u>ACTION</u>: MS. BARNEY made a motion, seconded by VICE CHAIRMAN CICHY to approve the amendments to the Employees' Retirement System Plan Document, which reflect recent plan design changes for Plans B and E adopted by the Commission at its July 18, 2018 and September 26, 2018 meetings under Commission Resolutions 18-21, 18-31 and 18-26. The motion PASSED unanimously (8-0). (Motion #18-44)

CHAIRMAN HEWLETT congratulated Patricia Barney on her retirement from the Maryland-National Capital Park and Planning Commission ("Commission") and recognized her stellar work with the Commission and the ERS for 35 years. Mrs. Barney's dedication and passion will truly be missed by the entire Commission family.

There being no further business, the Board of Trustees meeting of October 2, 2018 adjourned at 10:17 a.m.

RECOMMENDATION

At its November 6, 2018 meeting, the Employees' Retirement System (ERS) Board of Trustees ("Board") accepted the July 1, 2018 Actuarial Valuation presented by Boomershine Consulting Group and approved an employer contribution of \$19,245,489. An adjustment in the final report resulted in an employer contribution of \$19,244,687 which will be amended at the Board's December 4, 2018 meeting. As a result, we recommend the Commission approve Resolution #18-36 which adopts an employer contribution in the amount of \$19,244,687 (12.3% of covered payroll) for fiscal year 2020.

BACKGROUND

In accordance with the ERS' Plan Document, Section 2.3(g), the Board shall recommend to the Commission the contributions to be made by the Commission under the provisions of the ERS.

Each year the ERS has an independent actuarial valuation performed to determine the funding requirements for the ERS. The actuarial valuation is designed to measure the current and future cost of retiree benefits based on employee demographics, assets and liabilities, plan provisions, and actuarial assumptions and methods. The actuary recommends an employer contribution in order to ensure sufficient assets are available for future benefits.

A pension plan is well funded when it has enough money in reserve to meet all expected future obligations to participants. The ERS' funding objective is to meet long-term benefit promises through employee and employer contributions that remain approximately level as a percent of member payroll. The July 1, 2018 actuarial valuation indicated a funded ratio (based on the actuarial value of assets) of 94.9%, which is up from 90.7% in 2017.

The July 1, 2018 actuarial valuation includes: 1) a change in the investment return assumption from 6.95% to 6.90%, which is consistent with industry trends and was approved earlier this year following an annual review by Boomershine Consulting Group and 2) changes to the active member death benefits for employees in Plans B and E, which the Commission approved earlier this year by Resolution No. 18-21, 18-31, and 18-32.

To meet the ERS' funding objectives, the recommended employer contribution of \$19,244,687 (12.3% of covered payroll) is payable July 1, 2019 for fiscal year 2020. The recommended employer contribution decreased from \$24,792,093 (16.4% of covered payroll) as of July 1, 2017 primarily due to an actuarial error in the ERS' favor.

Boomershine Consulting Group's David S. Boomershine, Senior Consulting Actuary will present the attached presentation at the Commission's November 21, 2018 meeting.

WHEREAS, the Board of Trustees engaged Boomershine Consulting Group, L.L.C. ("the Actuary") to prepare an ERS Actuarial Valuation as of July 1, 2018; and

WHEREAS, the ERS Actuarial Valuation as of July 1, 2018 projected a Fiscal Year 2020 Plan Sponsor contribution in the amount of \$19,244,687.

NOW THEREFORE, BE IT RESOLVED, that the Commission as Plan Sponsor approves a \$19,244,687 payment to the ERS Trust Fund; and

BE IT FURTHER RESOLVED, that the Maryland-National Capital Park and Planning Commission does hereby authorize the Executive Director and other officers to take action as may be necessary to implement this resolution.





RECOMMENDATION

On behalf of the Board of Trustees ("Board") of the Maryland-National Capital Park and Planning Commission ("Commission") Employees' Retirement System ("ERS"), I respectfully request the Commission acknowledge Melissa D. Ford as the Prince George's County Open Trustee for the term ending June 30, 2021.

BACKGROUND

There has been a vacancy since July 2018 in the Prince George's County Open Trustee seat due to Alicia Hart's resignation from the Commission. In accordance with election procedures, three Notices of Election were placed in Update, on the ERS' and the Commission's websites with applications due in the ERS Office, August 24, 2018, September 21, 2018, and October 19, 2018, respectively. No applications were received for the first and second Notices of Election. Melissa D. Ford submitted an application following the third Notice of Election. No other applications were received. Ms. Ford is determined to have won by acclamation. At its November 6, 2018 meeting, the Board acknowledged Ms. Ford as the Prince George's County Open Trustee for the remainder of the term ending June 30, 2021.

Ms. Ford has worked for the Prince George's County Department of Parks & Recreation for eight years and is presently the Acting Budget Manager. Ms. Ford currently attends the University of Maryland and is a candidate for graduation this December with a graduate degree in Financial Management.

Background

On March 15, 2017, the Maryland-National Capital Park and Planning Commission (Commission) adopted Resolution 17-02 (Attachment A) for the purpose of regulating food and beverage vending machines located on Commission property. The Resolution established a Healthy Vending Machine Policy (Policy) that meets certain nutritional standards and reporting requirements. The policy is consistent with policies adopted in both Prince George's and Montgomery Counties. Section III (a) of the Policy states that all new vending machine service contracts and all vending machine service contract renewals entered into after July 1, 2017 shall comply with the requirements. Section VI (b) further states that each Department shall monitor compliance and issue a report to the Commission on the first anniversary of the Resolution, March 17, 2018. The Departments were charged with implementing this Policy upon entering into a new contract or renewing an existing contract and reporting on progress made to date.

This memo is provided for information purposes at this time as the assigned committee is continuing to implement contract requirements. We will provide an update as the committee finalizes requirements for vendor contracts. Meanwhile, should Commissioners desire further discussion of this item, staff can return to provide a briefing.

Reporting Compliance

Section VI (b) of the Policy states that the first report to the Commission shall include:

- (1) An assessment of Department compliance with this Policy;
- (2) Successes, challenges, and barriers experienced in implementation; and
- (3) Recommendations for improvement of the standards and compliance.

A committee consisting of the individuals who manage the various vending machine contracts and representatives from CAS-Purchasing, CAS-Legal and CAS-DHRM have had discussions about implementing the new standards. The focus of those discussions was on conducting a Commission-wide Request for Proposal (RFP) and developing language to include in existing and new contracts. Although some of the current contracts are month to month, the healthy vending requirements have not been incorporated into any existing contracts. However, it has been reported that the vending companies have been voluntarily including healthy items in their offerings. A separate work group, consisting of representatives from each Department, was established on July 26, 2018 to explore options for entering into new contracts. The members of the work group are, Donna Calcote (Legal Department), Jana Harris (Purchasing Division), Nakiia Buyck (Prince George's Parks and Recreation), Christine McGrew (Montgomery County Planning), Bryan Anthony (Prince George's Parks and Recreation), and David Alexander (Montgomery County Parks).

Reporting Updates

The goal of the Work Group was to:

- 1. Identify all active vending contracts that are subject to Resolution 17-02;
- 2. Identify methods to procure vendors (i.e. competitive or non-competitive solicitation);
- 3. Develop a contract template incorporating Resolution 17-02 healthy vending standards;
- 4. Negotiate with vendors for new contracts, incorporating healthy vending standards.

The group met on several occasions, with the last meeting occurring on Wednesday October 24th, to work toward meeting the above referenced goals. The Work Group has:

- Identified all active vending contracts that are subject to Resolution 17-02;
- Identified methods to procure vendors;
 - o Conduct our own solicitation;
 - o Bridge/ride an existing contract/solicitation;
 - Enter into direct contracts with vendors
- Developed a contract template that incorporates Resolution 17-02 healthy vending standards;

The Work Group has decided to bridge the existing contracts that Prince George's County Government has with two vending machine companies, Compass Vending d/b/a Canteen vending Services and Royale Dining Services. These contracts will cover vending machines in both Prince George's and Montgomery counties. The Purchasing Division anticipates scheduling meetings shortly with these vendors to discuss the process of implementing the new healthy standards machines throughout Commission facilities. Contracts with the companies that service the ice cream vending machines will be exempt from the healthy vending standards.



M-NCPPC RESOLUTION NO. 17-02

ADOPTION OF HEALTHY VENDING MACHINE POLICY

WHEREAS, According to the Centers for Disease Control and Prevention, 112,000 Americans die each year due to diseases such as heart disease, cancer, stroke and diabetes – diseases linked to poor nutrition, excess weight, and lack of physical activity; and

WHEREAS, One-third of all White children and half of all African-American and Latino children born today will likely develop type 2 diabetes in their lifetimes, according to the Centers for Disease Control and Prevention. Undiagnosed or uncontrolled diabetes can lead to debilitation, blindness, serious heart and kidney complications, amputations, and even death; and

WHEREAS, According to the American Academy of Pediatrics, the percentage of teenagers who were diagnosed with type 2 diabetes or pre-diabetes soared from 9% in 1999 to 23% in 2008; and

WHEREAS, Prevention and management of chronic disease is essential for improving the overall health, life expectancy, and quality of life for all patrons and employees of the Maryland-National Capital Park and Planning Commission ("M-NCPPC"); and

WHEREAS, M-NCPPC spends \$25 million each year to fund its employee health insurance program and invests additional dollars in its employee wellness program. Reducing chronic diseases through improvements to M-NCPPC's food environment may help improve employee health and reduce taxpayer costs; and

WHEREAS, According to the Centers for Disease Control and Prevention and other health experts, small steps, like making healthier food and beverages more widely available in vending machines, can help reduce Type 2 diabetes, obesity, and other chronic diseases; and

WHEREAS, the Commission desires to adopt a policy that promotes healthy eating by requiring healthy choices be included in vending machines on M-NCPPC property.

NOW THEREFORE, BE IT RESOLVED that the Maryland-National Capital Park and Planning Commission hereby adopts a policy setting goals and standards for the availability of healthy choices in vending machines on M-NCPPC property as reflected in ATTACHMENT 1 attached hereto; and

BE IT FURTHER RESOLVED that the Commission does hereby authorize the Executive Director and Department Directors to take action as may be necessary to implement this resolution.

HEALTHY VENDING MACHINE POLICY

I. Universal Vending Machine Requirements

- (a) The following criteria must be met by all items offered in vending machines.
 - (1) Any packaged food and beverage item offered shall contain no more than:
 - (A) 0.5 grams of trans-fat per serving; and
 - (B) 200 milligrams of sodium per package.
 - (2) Any beverage container offered shall contain no more than:

(A) 250 calories; and

(B) 20 fluid ounces.

II. Healthy Vending Standards

- (a) Healthy Food Choices shall meet the following specifications:
 - (1) Individual healthy food choices offered in vending machines must meet the following criteria:

(A) No more than 200 calories per package;

- (B) Less than 35% of total calories from fat except for foods containing 100% nuts or seeds with no added fats;
- (C) Less than 10% of calories from saturated fat; and
- (D) No more than 35% of calories from total sugars except for 1%, 2%, or non-fat dairy products, non-dairy milk products, fruits and vegetables.
- (2) At least one healthy food choice offered must meet the Food and Drug Administration's definition of "low sodium" (<140 mg per serving).
- (3) Sugarless chewing gum and mints also meet healthy food choices specifications.
- (b) Healthy Beverage Choices shall meet the following specifications:
 - (1) Individual Healthy Beverage Choices offered in vending machines must contain fewer than 40 calories per serving unless specified below.
 - (2) The following beverages also meet Healthy Beverage Choices nutritional standards even though they exceed 40 calories per serving: Fat-free milk; 1% low fat dairy milk; Calcium or vitamin D fortified soy milk with less than 200 calories per container; packages containing 12 ounces or less of 100% fruit juice, vegetable juice

or fruit juice combined with water with no added caloric sweeteners and no more than 200 milligrams of sodium per container.

(3) Vegetable juice must contain <230 milligrams of sodium per serving.

III. Healthy Vending Contract Requirements

- (a) All new vending machine service contracts and all vending machine service contract renewals entered into after July 1, 2017 shall require that:
 - (1) At least 50% of the food and beverage items offered in vending machines meet the requirements listed in Section (II) above.
- (b) The agency will strive to increase the 50% (percentage) in subsequent years.

IV. Product Placement

- (a) Healthy Food or Beverage Choices shall:
 - (1) Be displayed in a way that is easily distinguishable from food and beverages that do not meet Healthy Vending Standards listed in Section (II) above; and
 - (2) Be stocked in positions with highest selling potential.
- (b) Water without added caloric sweeteners is required to be stocked in beverage machines.
- (c) Beverages that do not meet the Healthy Vending Standards listed in Section (II) above shall be placed in positions with the lowest selling potential.

V. Pricing and Labeling

(a) Food and beverage items that meet the Healthy Vending Standards in Section (II) must be comparatively priced or less expensive than products that do not meet the standards.

(b) All vending machines shall display nutritional labeling that, at a minimum, complies with the standards for nutritional labeling set forth in 21 CFR, sections 101 and 109, as may be amended from time to time.

VI. Compliance, Evaluation and Reporting

(a) To assist and oversee the implementation of the nutrition and procurement standards required by this policy, each Department Head shall designate a staff person within the

Department to disseminate information and train M-NCPPC staff and vendors on the standards to support compliance.

(b) Each Department shall monitor compliance and issue a report to the Commission on the first anniversary of this Resolution and at least every other year. The report shall include:

(1) An assessment of Department compliance with this policy;

(2) Successes, challenges, and barriers experienced in implementation; and

(3) Recommendations for improvement of the standards and compliance.

(c) Future requests for bids and contracts for the procurement or provision of covered food and beverages shall incorporate the requirements of this policy. To facilitate monitoring and compliance with the requirements of this policy, future requests for bids and contracts for covered food and beverages shall require accurate and timely financial reports from vendors, provide for periodic reviews or audits of financial records, and include specific breach of contract and enforcement provisions relating to the requirements of this policy.

(d) Evaluation and reporting shall meet the following:

(1) At the end of the first year, June 30, 2018, the M-NCPPC will evaluate the results of the program and will assess what the new goals and standards should be, effective July 1, 2019.

(2) Before July 1, 2019, the M-NCPPC will provide a report to the Commission on the assessment of the program. Depending on the results of the assessment, the agency will strive to increase the healthy vending product requirements to a percentage greater than 50%.

(3) The agency will conduct a study of the number of products in vending machines that have artificial sweeteners and provide research data on the long-term effects of the use of artificial sweeteners. Depending on the results of the research, requirements regarding the use of artificial sweeteners may be added to the Healthy Vending Machine policy. A report will be presented to the Commission by July 1, 2018.

(e) From time to time but at least once every five (5) years, the Health and Benefits Office shall review, and if necessary, update the Healthy Vending Standards in Section (II) to reflect advancements in nutrition science, dietary data, new product availability, and/or updates to the Dietary Guidelines for Americans.

Background:

During the presentation in March 2017, Commissioner Geraldo requested that research be conducted on the effects of the use of sugar alternatives and substitutes. The purpose of the research was to determine if we need to amend the Healthy Vending Policy to address the use of artificial sweeteners. Currently, at least 50% of the food and beverage items offered in vending machines must meet the requirements listed in Section (II) of the Healthy Vending Machine Policy (See Attachment 1). The following is a summary of our findings.

Findings:

Based on our review of published research there are no consistent findings on the use of artificial sweeteners related to the effects on health. Furthermore, the FDA has approved the use of six artificial sweeteners including Saccharin (Sweet'N Low), Aspartame (Equal), Acesulfame Potassium (Sunnet), Sucralose (Splenda), Neotame (Newtame) and Advantame in food products. We suggest that offerings in our vending machines should not exclude snacks with artificial sweeteners until research findings are more consistent in showing negative effects on health.

Research was conducted on published studies issued on the long-term effects of artificial sweeteners on the body. Studies spanning the past 40 years have suggested alternately that sugar-substitutes may be 'potentially *helpful*,' 'potentially *harmful*,' or have 'unclear effects' regarding health. Evidence states that people who *frequently* consume sugar substitutes may be at an increased risk health issues (Scutti, 2013). Dr. Heather Tick (2016), explains that artificial

sweeteners are very addictive when consumed on a frequent basis. At this consumption level artificial sweeteners also cause inflammation, increase your insulin response, and can make you eat more and lead to obesity (Tick, 2016).

The FDA considers artificial sweeteners to be safe especially when consuming the acceptable daily intake (ADI). The FDA has established an "acceptable daily intake" (ADI) for each of the products. This represents the amount of a food ingredient that can be used safely daily over a lifetime without risk (Cleveland Clinic Health, 2013). Sugar substitutes are beneficial to individuals with type 2 diabetes. These individuals may choose to consume foods and beverages containing artificial sweeteners vs. those with added sugars as these sweeteners will affect blood sugars to a much smaller extent (Cleveland Clinic Health, 2013).

When exceeding the ADI, long-term effects that *may* occur after frequent consumption (1 beverage per day) of artificial sweeteners, include a negative effect on the brain, diabetes 2, hypertension and cardiovascular disease, weight gain and weight loss. Short term effects which may occur, include addiction, anxiety, dizziness, headaches, memory loss, mood swings, acne, bladder problems, bloating, stomach pain, migraines, muscle pain, skin rashes, and swelling (Scutti, 2013).

Research supporting that artificial sweeteners may cause long-term effects:

- Written in The Nutrition Source, artificial sweeteners affect the body's ability to gauge how many calories are being consumed. The human brain responds to sweetness with signals to eat more. Therefore, giving the body sweetness without any calories (zero calories) this causes humans to crave more sweet foods and drinks which leads to excess calories and weight gain.
- Similarly, research suggest that artificial sweeteners may prevent humans from associating sweetness with caloric intake. Therefore, we may crave more food and less nutritious foods. Holly Strawbridge (2018) of Harvard Health also supports this factor, stating that research suggests that artificial sweeteners may prevent humans from associating sweetness with caloric intake. As a result, we may crave more sweets, tend to choose sweet food over nutritious food, and gain weight.

 According to, Harvard T.H. Chan, School of Public Health, artificial sweeteners cause the following effects on health:

- Sugary drinks (containing artificial sweeteners) increase the risk of type 2 diabetes, heart disease and other chronic conditions
- People who consume 1 to 2 cans per day of sugary drinks (containing artificial sweeteners) have a 26% greater risk of developing type 2 diabetes.
- A study of men who averaged one or more cans of artificial sugary drinks per day for two decades had a 20% higher risk of having a heart attack or dying from a heart attack than men who rarely consumed artificial sugary drinks.
- According to Dr. Michael F. Jacobson some people develop headaches after consuming foods sweetened with aspartame. Research conducted by Tandel (2011), shows that aspartame has seizure-promoting activity in animals.
- There is some ongoing controversy over whether artificial sweeteners usage poses health risks. A study done in 2005 by the University of Texas Health Science Center at San Antonio showed that, rather than promoting weight loss, the use of diet drinks was a marker for increasing weight gain and obesity. Those who consumed diet soda were more likely to gain weight than those who consumed naturally-sweetened soda. Animal studies have convincingly proven that artificial sweeteners cause body weight gain.
- Sugar substitutes also affects dental care. It is shown that sugary drinks containing sugar substitutes such as sucrose can lead to dental decay. (Tandel, 2011).

Research supporting that artificial sweeteners may not cause long-term effects:

- According to The Nutrition Source, 2011 findings from the American Heart Association and American Diabetes Association conclude that when used judiciously, artificial sweeteners, low calorie sweeteners and non-calorie sweeteners "might" help with weight loss and could have beneficial metabolic effects.
- According to the National Cancer Institute there's no scientific evidence that any of the artificial sweeteners approved for use in the U.S. cause cancer
- Sucralose is **considered safe** for all segments of the population including people with chronic health problems such as diabetes. (Tandel, 2011)

According to Tandel (2011), in 1998, acesulfame K was approved by the US Food & Drug Administration for use in liquid non-alcoholic beverages and in 2003, general use approval was granted. The Joint Expert Committee on Food Additives (JECFA), the scientific advisory body to the World Health Organization and Food and Agriculture Organization of the United Nations, reviewed the available research on acesulfame K and stated that it is safe. Commonly found in chewing gum, beverages, marinades, ice cream, toothpaste, mouthwash and more.




