В. APPROVAL OF AGENDA

Chair Bliss asked for a motion to approve the agenda. Mr. Bolin moved to approve the agenda. Mr. Lee seconded the motion. The motion passed in a vote of 4-0-1 (Chair Bliss abstaining).

C. NEW BUSINESS

Mount Rainier General Store, 3301 Rhode Island Avenue – Javed Iqbal – Install illuminated channel letter signs.

Applicant: Mr. Igbal, representing Signtek, presented the application.

Staff: Mr. Sams summarized the staff report, noting that the proposed signs conformed to the development plan.

Committee: Committee members expressed concern that the individual pin mounting of the smaller letters would be difficult on the corrugated material and if removed in the future would leave multiple, unsightly holes in the building fascia. The applicant agreed that it was possible to mount the smaller letters on a raceway to address the committee's concern.

Mr. Lee moved to recommend approval of the application with the condition that the words, "General Store/Established 2017" be mounted on a plate or raceway to reduce the number of holes in the building fascia. Mr. Stachowicz seconded the motion. The motion passed in a vote of 4-0-1 (Chair Bliss abstaining).

D. ADMINISTRATIVE BUSINESS

1. Mr. Sams reminded the committee that all members' terms expired in October 2017 and the city should be in the process of collection nominations. Mr. Knedler stated that the city was actively seeking nominations and that notice had be made in *The Message*, the newsletter of the City of Mount Rainer, in the Winter 2018 edition, and that the city would close the application period on March 12, 2018.
