b) <u>I-495/I-270 Managed Lanes Study, Staff Recommendation: Draft Environmental Impact Statement (Borden)</u>

Deputy General Counsel Borden updated Commissioners on the I-495/I-270 Managed Lanes Study. In May 2021, the Maryland Department of Transportation State Highway Administration (MDOT SHA) announced it would only proceed with a National Environmental Policy Act (NEPA) study on a single segment of the project area, from I-495 at the American Legion Bridge, through I-270, stopping at I-370. The study will not include improvements from I-495 east of I-270 through Silver Spring, nor the segment from the I-95/I-495 split in Prince George's County through to the Woodrow Wilson Bridge.

Since the study will only cover areas in Montgomery County, future briefings will be made directly to the Montgomery County Planning Board (MCPB). Comments and information briefings will be brought to the full Commission, but actions will be decided by the MCPB.

Deputy General Counsel Borden said with the recent retirement of Managed Lanes Project Manager Carol Rubin, at the request of the MCPB, she will take over. Director Wright thanked Deputy General Counsel Borden and said she was confident the agency was in good hands. Chair Hewlett thanked both Ms. Rubin and Deputy General Counsel Borden for the work they both have done, adding special thanks to Deputy General Counsel for stepping up to the project.

c) <u>Life Insurance Benefit Update for All Employees (Chiang-Smith/Spencer/McDonald)</u> Corporate HR (CHR) Director Spencer provided background to Commissioners on the unfortunate passing of several agency employees. The losses were compounded when it was learned these employees were not enrolled in the agency's life insurance benefit, leaving families, some with small children, without added financial security after such a loss.

To encourage a higher rate of insured employees, the M-NCPC will be adding this benefit to all employees through an automatic enrollment process. The Benefits Office negotiated with the plan provider to waive proof of insurability (typically only done with enrollment at the time of hiring). The increased cost to both agency and employee is minimal. Moreover, if an employee does not want the insurance, they may opt out.

Employees will still split 20% of the cost of the premiums, with the M-NCPPC providing 80%. CHR Director Spencer said both collective bargaining units agreed to the change, and the benefit will begin for newly-enrolled employees in January 2022.

Executive Director Chiang-Smith praised CHR Director Spencer and his team for conducting a successful negotiation with the provider, especially for the waiving of insurability. She commended Director Spencer and the management team for successfully coming to an agreement with the MCGEO and FOP collective bargaining units on this topic.



Chair Hewlett and Commissioners praised CHR Director Spencer and his staff, along with the bargaining team.

Chair Hewlett also stressed to everyone the importance of taking care of yourself and your health, particularly with the spread of breakthrough cases, even if a person is vaccinated. Employees were reminded to please remain careful. Getting a vaccine is not just about protecting yourself; it's about protecting your family, protecting your friends and colleagues, and protecting your community.

Discussion	3a. Stand-by Compensation Policy (Beckham)
	Acting CPMO Director Beckham returned to the Executive Committee to present the item deferred from the October 2021 meeting after a request to provide more background and analysis on the program and Department Directors' opinions.
	The Executive Committee was asked to: 1. Approve making the pilot program permanent; 2. Approve minor changes to the program; and 3. Consider compensation model options.
	Mr. Beckham summarized the program, pending changes, and input collected from Department Heads from their meeting the week before as described in the packet. He described in detail the different compensation model options and the impacts of each. He said Department Heads supported the option to follow the status quo, noting Department Heads found the current system worked well. It was noted that adjusting to a different compensation model would create possible complications in implementation. The existing model compensates employees on standby assignments a flat 8 hours of straight pay or comp time.
	Vice-Chair Anderson said he was satisfied the team has examined the program, reconciled the rationalization of the approach, and supported the program, the changes, and the Department Heads' recommendation for keeping the current compensation model.
ACTION/follow-up	Chair Hewlett moved to adopt the recommendations. Vice-Chair Anderson seconded. Motion approved unanimously.
Discussion	3b. Proposed Amendments to Administrative Practice 2-31 and Accompanying Procedures 03-06 (TAP/Tuition Assistance Program) (Beckham)
	Acting CPMO Director Beckham introduced Policy Analyst Michael Doaks who asked for Executive Committee support to adopt minor revisions to the policy to improve program operations and benefits for employees. Mr. Doaks asked Executive Committee support for the following items:
	 Increase the annual tuition benefit for non-represented Merit System employees to mirror approved negotiated levels for MCGEO and FOP-represented employees. The annual benefit would increase to \$2000 for full-time employees and \$1000 for part-time employees; Clarify that any school/institution used in the program must be accredited by an organization recognized by the US Department of Education. This would also apply to vocational, technical and trade schools. Clarify the inclusion of foreign language/ASL classes for TAP eligibility.

	Mr. Doaks provided background and history of the program as reflected in the packet.
ACTION/Follow-up	Chair Hewlett moved to approve all three items. Vice-Chair seconded. Motion approved unanimously.
	Vice-Chair Anderson asked for a report on the use of the program, including information on patterns across departments, how broad is its use, what classes have been taken, what impact has it had on work programs. <u>ACTION</u>: VICE CHAIRMAN CICHY made a motion, seconded by MS. MILLAR to go into Closed Session. The motion PASSED unanimously (9-0). (Motion #21-45) During Closed Session, the following action was taken:

<u>ACTION</u>: MS. GOGOL made a motion, seconded by VICE CHAIRMAN CICHY to ratify the actions taken in Closed Session. The motion PASSED unanimously (9-0). (Motion #21-50)

ITEM 6 REPORT OF THE ADMINISTRATOR

Presentation by Andrea L. Rose, Administrator

A. Andrea L. Rose presented the Administrator's Report dated September 2, 2021. Ms. Rose reviewed the Board's calendar for committee and board meetings for September and October. Given there were no agenda items for the October meeting, CHAIRMAN HEWLETT cancelled the October 5, 2021 Board meeting.

Ms. Rose recommended the Board approve salary adjustments consistent with the recent adjustments adopted by the Commission for non-represented employees.

<u>ACTION:</u> VICE CHAIRMAN CICHY made a motion, seconded by MS. CHIANG-SMITH to approve a 3.5% increase for FY22 for eligible ERS employees; a 3.5% make-up increase for FY21 for eligible ERS employees paid the last pay period of FY22; a 1.75% increase for FY22 for eligible ERS employees at top of grade; and a 1.75% make-up increase for FY21 for eligible ERS employees at top of grade paid the last pay period of FY22, in accordance with the stipulations outlined in the Administrator's Report dated September 2, 2021. The motion PASSED unanimously (9-0). (Motion #21-51)

B. Memorandum dated August 3, 2021 re: PREM Eligible Securities

Northern Trust advised the ERS of Century and Lehman Brothers securities in the ERS' account that have been non-transferable for more than 6 years. These securities are eligible for removal under the Position Removal or "PREM" function which allows registered owners to relinquish their positions in issues that have had no transfer agent activity for an extended period. The issuers of these securities are generally inactive or insolvent and the lack of transfer agent renders the security non-transferable. The Securities and Exchange Commission approved this program in 1994 which permits removal and

destruction of the certificates representing positions in these securities. Destroying these certificates reduces costs and eliminates the need to store the certificates, maintain accounts, and monitor the status of these securities. If Northern Trust is not directed to PREM the eligible securities, the ERS will be charged \$250 per year for each security that remains on the record.

Wilshire Associates, Western Asset and Loomis Sayles confirmed there is no market for these securities and Bloomberg lists them as "defaulted". The cost of maintaining these certificates will exceed the value of these securities. Staff recommend the Board approve directing Northern Trust to proceed with removal of the Century and Lehman Brothers securities from the ERS' assets.

<u>ACTION</u>: MR. ZIMMERMAN made a motion, seconded by VICE CHAIRMAN CICHY to direct Northern Trust to proceed with removal of the Century and Lehman Brothers securities from the ERS' assets. The motion PASSED unanimously (9-0). (Motion #21-52)

ITEM 5 MANAGER REPORTS/PRESENTATIONS

A. Wilshire Associates

Presentation by Bradley A. Baker, Managing Director, and Martell McDuffy, Senior Analyst

The Statement of Investment Policy was revised to update the long-term assumptions in the Appendix as of June 2021. Mr. Baker confirmed the Statement of Investment Policy and assumptions are reviewed and updated periodically.

<u>ACTION:</u> VICE CHAIRMAN CICHY made a motion, seconded by MS. MILLAR to approve the Revised Statement of Investment Policy, as recommended by Wilshire Associates. The Motion PASSED unanimously (9-0). (Motion #21-53)

Caroline McCarthy left at 11:00 a.m.

Brad Baker provided a Quarterly Executive Summary for the quarter ending June 30, 2021 and reported on the fund's performance. The ERS' total fund return was 5.2% (net of fees) for the quarter, outperforming the target policy index return of 4.7%. For the one, three, five, and ten-years ended June 30, 2021 the ERS fund return was 21.5%, 9.6%, 10.3%, and 8.0%, respectively, compared to the target policy return of 20.4%, 9.8%, 9.5%, and 7.6%, respectively. The total market value through June 30, 2021 was \$1,109.6 million.

In comparison to peers as of June 30, 2021, the ERS had much less exposure to US and global equity and was overweight to private real estate. While the ERS had lower returns than most peers, the ERS had a lower risk profile than 94% of peers and ranked in the top quartile in terms of return per unit of risk. Wilshire has no concerns in terms of individual managers and their respective strategies.

In an email dated July 2, 2021 Aberdeen Standard Investments reported Jim Gasperoni decided to depart the business effective July 31, 2021. Ryan Sullivan will maintain oversight of the current portfolio of real assets investments and funds and will lead indirect private markets investments in infrastructure going forward. The ERS' current investments with Aberdeen will maintain their investment approach centered on investing across real estate, natural resources and infrastructure. These funds are in the liquidation phase and Wilshire is comfortable with the liquidation plan.

PGIM announced a fixed income organizational update on August 13, 2021. Nathan Sheets, Chief Economist and Head of Global Macroeconomic Research is departing PGIM on September 15, 2021. An external search for a replacement has been initiated. Wilshire has no concerns at present and will monitor the organization.

The Board meeting of September 14, 2021 adjourned at 11:30 a.m.







Mitigation Proposal by PGCPS for Glenridge Park

- PGCPS proposes to construct a replacement Multi-age Playground (2-5 & 5-12 year old) at the rear of the Glenridge Elementary School property.
- PGCPS shall execute a Recreational Facilities Agreement (RFA) for the construction of the Multi-age Playground, with an anticipated completion date in 2022.
- PGCPS will restripe the fields at Glenridge Elementary School for immediate use.
- The athletic fields at the new middle school will be available for shared use by the Commission.



Mitigation Proposal by PGCPS for Glenridge Park

- In addition, PGCPS has proffered a payment of \$920,000 as mitigation for the displacement of the additional facilities lost.
- With the receipt of the proffered payment, PPD has concept ideas for using the funds for new updated facilities, such as pickleball and futsal which are now in higher demand.
- The exact locations of these proposed facilities have not yet been determined.



SUMMARY

The new Glenridge Middle School will use approximately 15 acres of M-NCPPC property. PGCPS has agreed to a land exchange package consisting of the following:

- Conveyance of Glenridge Elementary School Site (14.8 acres) and portions of the Deerfield Elementary School (16.5 acres) **31.3 acres of land in total** (subject to final approval by MD DNR).
- Mitigation of the existing park facilities at our Glenridge Park Site shall include a fee payment and construction of a replacement multi-age playground.
- Based on the properties being conveyed to the Commission and the Mitigation Package proposed, the 15+/- acres at Glenridge Park, the 15 acres of Parkland will not be needed for Park Purposes.



In order to meet the demands for Middle Schools in Prince George's County, PGCPS is anticipating a start date of before the end of 2021 as soon as permits are obtained.

Next Steps

Land Exchange with PGCPS

- Approval of the Land Disposal by the Full Commission
- PGCPS will enter into a Right of Entry, Construction and Maintenance Agreement with DPR.
- Payment of the Facility Mitigation Fee (\$920,000) prior to the start of any construction on Park Property.
- Execution of the Land Exchange Agreement and RFA between PGCPS and the Commission by December 31, 2021.
- Obtain DNR approval for the POS replacement property prior to any Land Conveyances to PGCPS.

Land Exchange and Mitigation Package – Glenridge Middle School

RESOLUTION

WHEREAS, The Maryland-National Capital Park and Planning Commission ("Commission") is authorized under the Maryland Annotated Code, Land Use Article § 17-101 to acquire land or other property located within the Metropolitan District for parks, parkways, forests, roads, and other public ways, grounds, or spaces, and for public recreation; and

WHEREAS, the Commission is authorized under the Maryland Annotated Code, Land Use Article § 17-206 to dispose of recreational facility no longer needed for public use and to exchange recreational land for other land held by another public body or agency which the Commission determines to be more suitable for recreational purposes; and

WHEREAS, the Commission owns Glenridge Park, approximately 47 acres, consisting of Tax Map 51, Grid C1, Tax Map 43 Grid D4, Glenridge Local Park Parcel A (tax account 0145516), Part of Parcel 73 (tax account 0098962), Parcel 168-Woodlawn-Feldmans Addition (tax account 0145581), and Parcel A, Block U Addition to Woodlawn (tax account 0156224); and

WHEREAS, Prince George's County has a need for new middle schools and desires to site a new middle school at the Commission's Glenridge Park; and

WHEREAS, in 2018, Prince George's County Public Schools ("PGCPS") proposed a land exchange with the Commission; and

WHEREAS, PGCPS requested that the Commission convey to it: (a) $14.8 \pm$ acres of Glenridge Park in fee simple, $13.7\pm$ acres of which are encumbered with Maryland Department of Natural Resources ("DNR") Program Open Space covenants, for which DNR will require sufficient replacement property acceptable to DNR; and (b) $0.4\pm$ acres of Glenridge Park for ingress/egress, storm drainage, and utility easements associated with the construction of the new school; and

WHEREAS, in exchange, PGCPS proposes to convey to Commission: (a) 14.80 ± acres of Glenridge Elementary School, Tax Map 51, Grid D1, Parcel 7 (tax account 2176782) in two (2) phases: first, 7.4 ±acres consisting of rear fields, and second, the remainder within eight (8) years of the date of the execution of the Land Exchange Agreement; and (b) 16.5 ± acre portion of Deerfield Run Elementary School, Tax Map 10, Grid D3, Parcel A Wilcox Tract (tax account 1004027); and

- **WHEREAS**, at Glenridge Park, the Commission would lose a multipurpose football/soccer field with backstop baseball/softball overlay, covered picnic pavilion, parking lot and access road, multi-age playground, two (2) tennis courts, one (1) basketball court, one (1) sand pit volleyball court, and portions of existing trails; and
- WHEREAS, as mitigation for the Commission's amenities that would be lost, PGCPS proposes to: (a) construct a replacement multi-age playground at the rear of Glenridge Elementary; (b) restripe the fields at Glenridge Elementary School for immediate use by the Commission; (c) make the athletic fields at the new Glenridge Middle School available to the Commission when they are completed; and (d) pay the Commission \$920,000 as mitigation for the displacement of the facilities lost; and
- **WHEREAS**, the Commission would use such \$920,000 to construct replacement facilities, which may include pickleball and futsal, at locations to be determined; and
- **WHEREAS**, on November 21, 2019, the Commission's Prince George's County Planning Board (the "Planning Board") received a briefing on the initial terms of the proposed land exchange; and
- **WHEREAS**, on September 17, 2020, staff presented Mandatory Referral MR-1091F to the Planning Board; and
- WHEREAS, among other reasons, public acquisition of the PGCPS property at Glenridge Elementary School is advisable because: (a) it is contiguous to the Commission's Glenridge Park; (b) it is developable for active recreation; and (c) it would promote trail linkages and/or connections to other parkland or open spaces; and
- WHEREAS, among other reasons, public acquisition of the PGCPS property at Deerfield Run Elementary School is advisable because it is developable for a replacement of or expansion of existing Deerfield Community Center and the preservation of the stream valley; and
- **WHEREAS**, the Planning Board authorized DPR to negotiate for the disposal of the M-NCPPC property and acquisition of the PGCPS property; and
- WHEREAS, PGCPS will enter into a Right of Entry, Construction and Maintenance Agreement with the Commission to allow it to begin construction; and
- WHEREAS, the land exchange will be documented by a Land Exchange Agreement, and PGCPS's construction of the playground and payment of the \$920,000 (due prior to the start of any construction on park property) will be documented by a Recreational Facilities Agreement, both documents to be executed by December 31, 2021; and
- **WHEREAS**, the Commission will not convey any of its property to PGCPS before DNR approves of the replacement property.

NOW, THEREFORE, BE IT RESOLVED, that the Prince George's County Planning Board, at closed session during its meeting on <u>September 16, 2021</u>, finds that in light of the proposed acquisition of land at Glenridge and Deerfield Run Elementary Schools, the M-NCPPC property at Glenridge Park will not be needed for park purposes and may be disposed.

FURTHER RESOLVED, that the Planning Board hereby approves the land exchange with PGCPS (subject to approval of the full Commission) and the proffered mitigation package.

FURTHER RESOLVED that, in connection with the transactions contemplated herein, the Executive Director is authorized to execute and deliver, on behalf of the Commission, any and all such deeds, certificates, documents, and/or instruments, and to do or cause to be done, any and all such acts, as the Executive Director deems necessary or appropriate to make effective or to implement the intended purposes of the foregoing resolutions, without limitation, the taking of such actions shall be deemed conclusively to be authorized hereby.

RECOMMENDATION

At its November 2, 2021 meeting, the Employees' Retirement System (ERS) Board of Trustees ("Board") accepted the June 30, 2021 Actuarial Valuation presented by Cheiron. As a result, the Board recommends the Commission approve Resolution #21-26 which adopts an employer contribution in the amount of \$25,682,999 (14.43% of covered payroll) for fiscal year 2023.

BACKGROUND

In accordance with the ERS' Plan Document, Section 2.3(g), the Board shall recommend to the Commission the contributions to be made by the Commission under the provisions of the ERS.

Each year the ERS has an independent actuarial valuation performed to determine the funding requirements for the ERS. The actuarial valuation is designed to measure the current and future cost of retiree benefits based on employee demographics, assets and liabilities, plan provisions, and actuarial assumptions and methods. The actuary recommends an employer contribution to ensure sufficient assets are available for future benefits.

A pension plan is well funded when it has enough money in reserve to meet all expected future obligations to participants. The ERS' funding objective is to meet long-term benefit promises through employee and employer contributions that remain approximately level as a percent of member payroll. The June 30, 2021 actuarial valuation indicated a funded ratio (based on the actuarial value of assets) of 92.6%, which is up from 91.2% in 2020.

The June 30, 2021 actuarial valuation includes demographic and economic changes, including a change in the investment return assumption from 6.80% to 6.75%, which were approved by the Board earlier this year following a five-year experience study.

To meet the ERS' funding objectives, the recommended employer contribution of \$25,682,999 (14.43% of covered payroll) is payable July 1, 2022 for fiscal year 2023. The recommended employer contribution decreased from \$26,174,744 (15.18% of covered payroll) as of July 1, 2020. The decrease in the employer contribution from 2020 to 2021 can be primarily attributed to: 1) a \$25.7 million actuarial gain on investments; 2) a \$6.8 million gain on the liabilities due to COLA increases being less than expected for retirees and salary increases being less than expected for active members; and 3) a \$11.3 million decrease in the unfunded actuarial liability which resulted from a large actuarial gain offset by the increase in liability due to the change in demographic and economic assumptions.

Cheiron's, Janet H. Cranna, FSA, EA, MAAA, Principal Consulting Actuary and Patrick Nelson, FSA, EA, MAAA, Associate Actuary will present the attached presentation at the Commission's November 17, 2021 meeting.















Projections – 5.25% Annual Return





The purpose of this presentation is to present the actuarial valuation results for the Maryland-National Capital Park and Planning Commission Employees' Retirement System (System). This presentation is for the use of the Board, System staff, and the Commission.

In preparing our presentation, we relied on information, some oral and some written, supplied by the System. This information includes, but is not limited to, the plan provisions, employee data, and financial information. We performed an informal examination of the obvious characteristics of the data for reasonableness and consistency in accordance with Actuarial Standard of Practice No. 23.

The actuarial assumptions and methods are outlined in the 2021 MNCPPC ERS Experience Study presentation on May 4, 2021. The census data provided to us by the System was as of June 30, 2021.

The assumptions reflect our understanding of the likely future experience of the System, and the assumptions as a whole represent our best estimate for the future experience of the System. The results of this presentation are dependent upon future experience conforming to these assumptions. To the extent that future experience deviates from the actuarial assumptions, the true cost of the System could vary from our results.

Cheiron utilizes and relies upon ProVal, an actuarial valuation software leased from Winklevoss Technologies for the intended purpose of calculating liabilities and projected benefit payments.
