Chair Hewlett reminded Commissioners of the One-Commission Legislative Event on Wednesday March 20, 2019 from 3:30-5:30 pm in Annapolis. She commended the Diversity Council for the wonderful Women's History Month Event held on Friday, March 8, stating keynote speaker Commissioner Fani-Gonzalez did a great job.

Chair Hewlett also mentioned St. Patrick's Day, National Colorectal Awareness Month and National Nutrition Month.

ITEM 5 ACTION AND PRESENTATION ITEMS

a) Review of Standby Compensation Pilot Program and adoption of Resolution 19-01 for the program (Harvin/Beckham/Coburn)

Acting Executive Director Bennett asked the Commission to approve a 1-year pilot program for standby compensation to recognize after-hour coverage of critical programs for IT and trades managers. She added both unions have similar models to address critical coverage provided by police and service/labor employees. Department Heads and Executive Committee have recommended approval of the program. Acting CPMO Director Harvin and Policy Manager Beckham presented the Resolution, adding if adopted, operating procedures will be drafted. Mr. Beckham said the need for the standby program for certain non-represented positions was identified by Department Heads. Comprehensive review was conducted with operating departments representatives, IT sections, DHRM and Legal. After extensive review, Department Heads and staff determined that IT Staff and Trade Shop Supervisors below the Division Chief level are frequently required to provide regular after-hours coverage. Mr. Beckham described the proposed compensation program for after-hours support. The pilot program will be for one year, after which the needs will be re-evaluated.

Commissioner Patterson asked about compensating the employee with compensatory leave rather than pay and asked how much can be carried over from calendar year to calendar year. Acting Executive Director Bennett clarified the compensatory leave carryover. Commissioner Cichy asked if the week is considered Sunday to Saturday or can it float. Mr. Beckham replied it was fixed on Sunday to Saturday, to follow the pay period. Commissioner Doerner asked about the insurance aspects of the policy, in terms of travel time and the agency having any liability if the employee gets into an accident during afterhours work. Acting Executive Director Bennett replied employees are covered while performing assigned agency duties.

Seconded by Doerner 7 approved the motion

b) Literacy Program Update (Shearer)

Acting Executive Director Bennett introduced Management Analyst Nathan Shearer and described the Language and Literacy Program, which has seen considerable success after its re-launch and redesign. Mr. Shearer reviewed the program and current initiatives. He described some of the changes made to the program over the past few years, based on

feedback, including class time/scheduling, marketing and outreach, and data collection to measure success of the program over time. He noted the program has had a positive effect on career enhancements, noting 7% of program participants received promotions, compared to a 5.5% rate in the general workforce. Feedback from students and managers indicated participants felt more committed to their work, they were given new and increased responsibilities, and had greater job success.

Chair Hewlett praised the success of this program, approved of the marketing plans to boost enrollment, and suggested asking current participants to be ambassadors. Commissioner Washington added her congratulations and asked if there were any classification series where being bilingual was a requirement. Human Resources Director Spencer said none required it, but some position descriptions state that it is highly preferable. Commissioner Washington suggested positions would benefit from bilingual applicants. Commissioner Cichy asked how participants are prepped for advancement, wanting to know if they have any job or advancement coaching, or help filling out forms. Mr. Shearer reported the classes are designed toward reading regulations and increased comprehension but said the program could add that kind of help. Commissioners Doerner and Patterson suggested cross-marketing the program at various Hispanic Heritage month activities.

Vice-Chair Anderson added his praise for the program, saying this program, along with other self-improvement programs has made him incredibly proud of working with Chair Hewlett and for this agency. He said the Commission is a family, and this program conveys that we care about our employees' welfare as individuals and strengthens our community.

c) PMO Status Update (Chilet) (information item only) No discussion.

d) <u>Status Report – 2018 Summer Employment Program for People with Disabilities</u> (<u>Spencer/Glover</u>)

Human Resources Director Spencer introduced updates on the Summer Employment Program for People with Disabilities, which he noted reflects the goals of the agency and aligns with the agency's vision as an organization. He introduced Program Manager Jeannette Glover, who provided more information. The program started 23 years ago and enables the agency to provide employment experiences for people with disabilities. In 2018, the M-NCPPC interviewed more than 100 people with disabilities for 50 positions identified for the program and filled 48 positions. Ms. Glover described the positions offered by departments for the program and conveyed stories of some of the participants. She reported most were in summer camp counselor and assistant counselor positions and noted there was a demand for more office and park maintenance positions. Ms. Glover described manager survey responses on employee performance, items that were working well in the program, and areas that could use improvement. She concluded by sharing that the 2019 program will kick off this month.

Commissioner Patterson praised Ms. Glover on the report and the program overall, adding that she hoped Montgomery County Departments can join the program in the future.

Commissioners Patterson and Washington asked about marketing efforts for the program. Ms. Glover replied the marketing focuses on high schools and advocacy/job coaching organizations such as Melwood and added the age range for participants included teenagers through people in their 50s. She also added people who apply with the support of advocacy organizations typically do better in the application process and are more likely to be hired. Commissioner Patterson suggested reaching out to senior centers as well. Commissioner Doerner asked about transportation assistance for the program, and if the agency subsidized it. Ms. Glover replied participants usually have family members transport them, or use Metro Access and public transportation, but the agency does not subsidize fees. Chair Hewlett clarified that Metro Access has a reduced charge. Commissioner Doerner suggesting transportation could be a determining factor and suggested the agency might offer a subsidy in order to increase the participation/application rate. Commissioner Cichy said program staff might contact representatives of Ride-on, Metro Access or The Bus. Human Resources Director Spencer said there is already keen interest in the program, and typically they do not have enough positions to give all applicants a job.

Human Resources Director Spencer stated program staff met with the therapeutic recreation staff in Parks and Recreation and they are considering evolving the program into an enrichment program for current employees as well as an employment program. Program staff will be asking for input from department representatives to determine the future direction of the program. Commissioner Washington suggested program staff should start measuring other factors to gauge the program's success and evolution, including transition and support to go on to career positions. There was discussion among Commissioners about using the term "high functioning" in hiring qualifications, and they suggested moving away from that term to something more quantitative and descriptive to best match a participant's ability level with the needs of the individual job.

e) <u>Briefing on Preliminary FY20 Spending Affordability Guidelines for Montgomery County</u> (Kroll)

Corporate Budget Manager Kroll presented on the agency's response to Spending Affordability Guidelines imposed by the Montgomery County government in February 2019. The agency is expecting a 5 percent reduction from the proposed budget, or approximately \$6.5M in Montgomery County funded departmental budgets, including bi-county departments. The agency would learn exact figures later in the week. Reductions will be complicated in the bi-county departments, since budget cuts will affect service levels for both counties.

Mr. Kroll stated departments were identifying potential cuts to meet the required reduction. He noted the agency used certain tools last year to reduce spending, but those strategies were not available this year. Bi-county budget staff are currently looking at operations and programs with the least impact, but cuts will be difficult. Staff will present to the Montgomery County Planning, Housing and Economic Development (PHED) Committee on April 24. Chair Hewlett thanked Mr. Kroll for the information. There were no questions.

	wage to \$15/hour by 2025 has passed. The M-NCPPC is obliged to meet State wage				
	standards and currently exceeds what is set by the State, matching Prince George's				
	County minimum wage of \$11.50/hour. In FY18, Montgomery County enacted a				
	minimum wage increase which exceeds the current State, M-NCPPC and Prince				
	George's County minimum wage levels. The M-NCPPC will need to consider whether				
	to stick to only implementing the changes mandated by State law or go beyond these requirements.				
	Chair Hewlett stated that while the State and Montgomery County have made their wage plans clear, Prince George's County has not yet decided whether to adopt increases over the State's new rates, and the Commission must consider each county and the State when making a decision. Prince George's County's decision will have an impact on what the agency does, considering more than 80% of the M-NCPPC's minimum wage workers are in the Prince George's County Department of Parks and Recreation. Any change will have a large impact on the Prince George's budgets. Corporate Budget Director Kroll noted that the State law has no budgetary impact for FY20 and will have only minimal impact on FY21. But any increase, up to and includin				
	matching Montgomery County's minimum wage, will have a considerable impact.				
	Both Chair and Vice-Chair noted it is beneficial to get the input of their respective

MS. MILLAR arrived at 10:13 a.m.

Cherion was retained to conduct a full-scope actuarial audit of the July 1, 2017 Actuarial Valuation and to review the most recent Experience Study covering July 1, 2011 to June 30, 2015 performed by Boomershine Consulting Group (BCG).

Janet Cranna reported that overall, Cheiron found the assumptions and methods used in the July 1, 2017 Actuarial Valuation generally sound and reasonable and that they conform to the appropriate Actuarial Standards of Practices (ASOPs). Cheiron made recommendations that certain assumptions be clarified and/or disclosed in future actuarial valuation reports and/or experience studies as detailed in Audit Report of the July 1, 2017 Actuarial Valuation.

Based on a full replication of the actuarial valuation, Cheiron found the calculations of the present value of future benefits, actuarial liability, and normal cost below the industry standard of 5% for some plans. As a result of these differences, Cheiron's calculations of the employer contributions was 70% of that of BCGs. Specific details are contained in the Audit Report of the July 1, 2017 Actuarial Valuation.

Ms. Rose asked if the calculation errors were corrected, would Cheiron's results be in the 5% reasonableness range. Ms. Cranna indicated that it is hard to tell and recommended having BCG re-run the July 1, 2017 Actuarial Valuation for the corrections.

Andrea Rose recommended the Board refer the results of the Actuarial Audit to the Administrative & Personnel Oversight Committee ("Personnel Committee") for review and recommendation. The Board agreed and asked the Personnel Committee to follow up with a recommendation.

Bradley Baker reported on the fund's performance for the quarter ending September 30, 2018. The ERS' total fund return was 2.41% (net of fees) for the quarter, underperforming the actual policy index return of 2.45%. The ERS fund return was 7.06% for the one-year ended, 10.45% for the three-years ended, and 6.86% for the five-years ended September 30, 2018 versus the actual policy index which returned 6.12%, 9.11% and 5.90%, respectively. The total market value through September 30, 2018 was \$957.9 million.

Mr. Baker agreed to add the peer median and total value paid-in to the Executive Summary - Private Assets Investment Review page and to revise the fixed income detail on the Monthly Summary page.

Ms. Rose informed the Board that following the November 6, 2018 Board meeting, an adjustment was discovered while preparing the final July 1, 2018 Actuarial Valuation Report which resulted in a revised employer contribution of \$19,244,687 (12.3% of covered payroll). This amount was approved by the Commission at its November 21, 2018 meeting. Ms. Rose asked for a motion to amend Motion #18-48 and adopt the revised employer contribution.

ACTION:

MS. BENNETT made a motion, seconded by MS. WALSH to Amend Motion #18-48 and Adopt a Revised Employer Contribution of \$19,244,687 (12.3% of covered payroll) payable July 1, 2019 for fiscal year 2020.

Staff consulted with SB & Company regarding the actuarial error and recommended updates to the Comprehensive Financial Report (CAFR). The Schedule of Employer Contributions in the CAFR was updated to reflect the revised employer contribution. However, after reviewing the revised GASB 67 & 68 Report from BCG, SB & Company determined the changes related to GASB 67 & 68 to be immaterial. Since SB & Company had already signed off on the ERS' CAFR, only a change to the Schedule of Employer Contributions was recommended. Copies of the updated CAFR were provided along with the Popular Annual Financial Report which summarizes the CAFR. Both reports are available on the ERS' website for download.

Ms. Rose presented the 2019 Board of Trustees Work Program and Meeting Dates.

As you know from the reports by our General Counsel Adrian Gardner, the Maryland-National Capital Park and Planning Commission has been defending a lawsuit filed by the American Humanist Association and several individuals who object to our agency's ownership of the historic Peace Cross World War I memorial in Bladensburg, Maryland.

Last Spring, after the United States Court of Appeals for the Fourth Circuit issued an adverse decision in the case, the Prince George's County Planning Board decided to pursue an appeal in the Supreme Court of the United States. Toward that end, the General Counsel solicited proposals from a number of prominent legal service providers to represent our agency by filing a petition for certiorari and, if such a petition was granted, to handle the case on the merits. Neal Katyal, a partner in the international law firm of Hogan Lovells and professor of constitutional law at the Georgetown University Law Center, was among the practitioners whom Adrian invited to tender a proposal. Ultimately, Mr. Katyal responded and Adrian selected him and the firm for the engagement.

After a kick-off meeting at Riversdale Mansion with the Planning Board, Mr. Katyal, Senior Associate Mitchell Pearsall Reich and the rest of the Hogan Lovells team has been very busy and diligently working on our case. The Supreme Court granted our petition, and Mr. Katyal proceeded to argue the case last month, which I was able to observe with Commissioners Manny Geraldo, Will Doerner and a few people from our legal team. That was a profound experience that we will never forget.

For these reasons, I respectfully request that our Commission formally acknowledge and thank Mr. Katyal and Hogan Lovells for their contributions to our agency and the communities we serve. I will accordingly invite an appropriate motion to adopt the attached resolution during our meeting later this month.

WHEREAS, the Commission sought legal consultation from Hogan Lovells US LLP, a firm with roots dating to the late Nineteenth Century, and which has extensive experience in constitutional law and complex appellate litigation, among many other disciplines;

WHEREAS, Hogan Lovells partner Neal Kumar Katyal, a former Acting Solicitor General of the United States who has had more than three dozen career appearances before the United States Supreme Court, assumed oversight of the Commission's litigation;

WHEREAS, Hogan Lovells and Neal Katyal have imparted exemplary wisdom and have demonstrated tremendous competence and capabilities regarding their handling of this Peace Cross matter;

WHEREAS, Hogan Lovells and Neal Katyal have conferred a remarkable benefit in service to the residents of Prince George's County, the said Regional District and Metropolitan District, as well as the public more generally; and

WHEREAS, as a body corporate and politic of the State of Maryland, the Commission desires to express to Hogan Lovells and Neal Katyal the body's enduring gratitude for the act of public service in undertaking the legal representation of the agency before the Supreme Court of the United States in the matter of Maryland-National Capital Park and Planning Commission v. American Humanist Association et al., No. 18-18, October Term 2018, on Writ of Certiorari to the United States Court of Appeals for the Fourth Circuit.

SUBJECT: Commission-Wide IT Budget Adjustment – NeoGov Onboarding Project

Background:

NeoGov is the software the Commission utilizes for applicant tracking. In order to gain greater efficiency, the Commission proposes to interface this system with the Infor HR system. This would result in completing the automation of the entire recruitment management cycle.

The IT Council, after reviewing the details of this proposal, agreed to seek funding for it. PGC Department of Parks and Recreation, being the largest beneficiary of a more efficient hiring process, agreed to fund the cost.

Cost and Benefits:

One-time cost for the first year, including the NeoGov module, consultant (RPI) implementation, and training is \$92,600.

Benefits include:

- Automation and elimination of data entry duplication for all activities through workflows
- Digital forms and approval workflow will be completed in the system
- Visibility through coordinated process monitoring, notifications, alerts and escalations
- Recruitment administration of Commission-Wide content and support to departments as Subject Matter Expert on Module
- Process can be extended to Term Contract and Seasonal personnel reduces variation in onboarding experience for all new hires
- Streamline "First Day" agenda to release new employees to departments earlier or to add new activities (such as revived One Commission Tour)

Action Requested:

Because the CIO's function is bi-county, the transfer of funds from the PGC Park and Recreation Funds, and the authorization to proceed with this project must come before the full Commission.

The request, therefore, is to transfer \$46,300 from the PGC Park Fund and \$46,300 from the PGC Recreation Fund to the Commission-Wide IT Initiatives (CWIT) Internal Service Fund, and authorize the expenditure of \$92,600 from the CWIT Fund.

Requested Action

In FY19, the Department of Human Resources and Management (DHRM) is projected to have approximately \$425,000 in savings in personnel costs due to unexpected retirements and other unanticipated position turnover. We are requesting approval of a budget transfer of \$375,000 to address priorities identified with operating departments and prefund areas affected by significant cuts the department must take in its proposed FY20 budget to meet reductions necessitated by Montgomery County's budget.

Due to the bi-county nature of services delivered by this department, reductions taken to Montgomery County funded services also require corresponding reductions in services which are delivered to Prince George's operations. Consequently, FY20 Proposed Budget reductions have a significant impact on the department's ability to deliver services that operating departments and Planning Boards have identified as critical. The use of salary savings will help us prefund areas including priorities communicated by Planning Boards. We appreciate your consideration and support of our request.

Proposed Use of Lapse/Savings

- <u>Budget Planning Software and HRIS Support</u>: \$55,000
 Savings will be used toward the acquisition and implementation of updated agency-wide budget planning software. The current budget planning platform is no longer supported by its developer. Additionally, technical support is needed to test, streamline and improve reliability of the high volume personnel actions handled by the Human Resources Information System.
- <u>Legal Services</u>: \$105,000
 Savings will be used to help prefund legal support needed for collective bargaining and other complex grievance investigations/arbitration matters.
- Consulting Services for Classification Study and Succession Planning: \$140,000
 Savings will be used for consulting services to implement Commission-supported recommendations from the agency's Classification and Compensation Study and address critical succession planning needs for the agency.
- Consulting for Planner Diversity Study: \$25,000
 Savings will be used in conjunction with savings from the Legal Department to fund an analysis of the diversity study of planning positions based on discussions with Department Heads and the Executive Committee.
- Needed Technology Support and Hardware: \$50,000:
 Savings will be used to address needed technology to support official meetings of the agency, grievance hearings, training, remote interviews, new hire prestations and Merit Board meetings.

SUBJECT: Request to Reallocate FY 2019 Legal Department Salary Lapse

This memorandum is to request your authorization to reallocate this year's expected salary lapse for the Legal Department for the purposes described below.

Background

The Legal Department is experiencing an ongoing spate of disruptions in its personnel complement this year. Taken together, a variety of staffing changes during FY 2019 has resulted in a projected salary lapse of approximately \$635,000. A breakdown of the major factors contributing to this number includes:

Vacancies for temporary transfers of 2 lawyers to other operating departments (Mont. Co. Planning Department and DHRM) \$286,000
 Lapse from turnover \$187,000

• Favorable variances in starting compensation \$53,000

For some perspective, <u>each</u> of the four major legal teams has experienced a vacancy at some point during the fiscal year for differing reasons.

Recommendations

I am recommending, and requesting Commission approval, to reallocate and apply the savings from FY 2019 projected salary lapse (Personnel Services) to the following non-personnel expenditure budget categories and uses:

1. Montgomery County FY19 Savings Plan.

We will apply a portion of the lapse to meet the Montgomery County mandate to trim FY 2019 spending – the "savings plan." Contrary to our initial plan to use a one-county cut, we recognize that the reduction can be jointly allocated to the administrative fund (in both counties) without any impact to service levels or otherwise.

2. Temporary Services.

The department has employed a strategy for mitigating the workload disruption from staff vacancies by utilizing temporary legal service firms to backfill (where feasible). This approach is expected to continue for the last quarter of the fiscal year.

3. Disparity Research and New Procurement Regulations.

With the Commission's support, the General Assembly enacted HB 1279 – entitled "MNCPPC - Procurement - Source Selection" – that authorizes the Commission to adopt programs for MBE and/or small-local business procurement. The Finance Department's plan to implement this legislation involves two discrete phases that require professional services: (1) empirical research to evaluate the legal predicate for including preferences in the MBE procurement program and (2) technical consulting to rewrite the agency purchasing regulations. (See attached.)

4. Planner Diversity Study.

Based on discussions among the HR Director, Executive Committee and Department Heads, the Legal Department has been tasked with leading an empirical analysis of agency-wide diversity outcomes among incumbents in professional planning jobs. The plan includes soliciting appropriate public interest partners — e.g., APA, University of Maryland, etc. — to consider engagement for delivering this project.

5. Legal Fee Rebates.

Over the course of the year, both the Montgomery County Parks Department (MCPD) and Prince George's County Department of Parks and Recreation (DPR) have incurred direct expenses to pay outside legal counsel involved in certain transactions or disputes. Given the existing and future budget pressures on each department – especially MCPD – we have determined that a portion of the FY 19 expenses for each department are eligible for a funding "swap" – using OGC's lapse as the source for the rebate.

6. Prefund Legal Fees for Outside Counsel.

The Commission has experienced a significant uptick in disputes over construction projects in both counties. This reallocation will defray future expenses that will otherwise be incurred directly by MCPD and/or DPR.

House Bill 1279 (Montgomery County Delegation and Prince George's

County Delegation)

Health and Government Operations Education, Health, and Environmental Affairs

Maryland-National Capital Park and Planning Commission - Procurement Source Selection MC/PG 112-19

This bill authorizes the Maryland-National Capital Park and Planning Commission (M-NCPPC) to establish a minority business enterprise (MBE) program, under specified conditions, and a local small business enterprise (SBE) preference program. Authorization for the MBE program terminates October 1, 2022. M-NCPPC must also adopt procurement regulations consistent with standards and methods for source selection in State law. The bill requires specified State and local entities to provide specified support to M-NCPPC to implement the bill's provisions. **The bill takes effect June 1, 2019.**

Fiscal Summary

State Effect: None. Specified State agencies can provide assistance, as required under the bill, to M-NCPPC with existing resources. Revenues are not affected.

Local Effect: M-NCPPC expenditures may increase by \$300,000 in FY 2020 to conduct a disparity study, with ongoing costs of about \$120,000 for staffing beginning in FY 2021 to administer the MBE and SBE programs. No effect on revenues.

Small Business Effect: Meaningful.

Analysis

Bill Summary:

Definitions

"Local small business enterprise" means a business enterprise that has its principal place of operation in Montgomery County or Prince George's County and has been certified as an SBE by either county.

"Minority business enterprise" has the same definition as in State law.

Disparity Study

Montgomery and Prince George's counties may provide sufficient resources to implement the bill, including funding necessary to conduct a study or analysis required to determine whether MBEs or local small businesses have been underutilized. The Special Secretary of the Governor's Office of Small, Minority, and Women Business Affairs and the Secretary of Transportation must ensure that M-NCPPC is provided with appropriate technical assistance and information related to the MBE disparity study conducted by the State in 2017. M-NCPPC may use the information to evaluate whether or the extent to which it may have underutilized MBEs.

Minority Business Enterprise Program

If, based on the results of the disparity study and other legally relevant data, M-NCPPC elects to establish an MBE program, the program may include:

- procedures to maximize notice to MBEs and the opportunity for them to participate in the procurement process;
- provisions to extend reasonable preferences or goals for certified MBEs, as specified; and
- to the extent practicable, provisions consistent with the State's MBE program.

Small Business Enterprise Program

If M-NCPPC elects to establish a local SBE program to encourage local small businesses to participate in procurement activities, the program may include:

• procedures for reliable documentation of a business entity's official designation as an SBE by either Montgomery County or Prince George's County;

- procedures to maximize notice to SBEs and the opportunity for them to participate in the procurement process; and
- provisions to extend reasonable preferences and procurement goals for SBEs and to reserve particular procurement activities for local SBEs.

By October 31 of each year, M-NCPPC must report to the Montgomery County and Prince George's County delegations on the effectiveness of any MBE or local SBE programs established under the bill.

Current Law: For a complete description of the State's MBE program and the most recent disparity study, please see the **Appendix – Minority Business Enterprise Program**.

State Qualification as a Small Business

Chapter 75 of 2004 defined a "small business" as either a certified minority-owned business or a business other than a broker that is independently owned and operated, not a subsidiary of another firm, and not dominant in its field of operation. In addition, Chapters 538 and 539 of 2012 (as amended by Chapter 76 of 2014) established that, to qualify as a small business, a business must meet *either* of the following criteria in its most recently completed three fiscal years:

- the firm did not employ more than 25 people in its retail operations; 50 people in either its wholesale or construction operations; or 100 people in either its service, manufacturing, or architectural and engineering operations; or
- average gross sales did not exceed \$2.0 million for manufacturing operations, \$3.0 million for retail operations, \$4.0 million for wholesale operations, \$4.5 million for architectural and engineering services, \$7.0 million for construction operations, and \$10.0 million for service operations.

Small businesses self-report their small business status by registering on eMaryland Marketplace, the State's online procurement portal. More than 6,000 businesses have self-qualified as small businesses.

Background: M-NCPPC is a bi-county agency responsible for a regional system of parks and land use planning in Montgomery and Prince George's counties, as well as a public recreation program in Prince George's County. M-NCPPC was first authorized to operate a Minority Business Enterprise Utilization Program in 1992, subject to the findings of a disparity study, but the program terminated September 30, 2013 (after multiple reauthorizations). According to the bill's preamble, M-NCPPC has reported that its utilization of MBEs declined when its utilization program terminated.

Local Expenditures: M-NCPPC advises that its expenditures may increase by \$300,000 in fiscal 2020 to hire a consultant to conduct a disparity study using the data available from the State's study, and for other related costs. Beginning in fiscal 2021, M-NCPPC expenditures may increase by \$120,000 to employ a compliance officer to administer the MBE and local SBE programs.

Small Business Effect: Small, minority- and women-owned businesses in Montgomery and Prince George's counties may benefit from procurement preference and/or set-aside programs administered by M-NCPPC.

Appendix – Minority Business Enterprise Program

The State's Minority Business Enterprise (MBE) program requires that a statewide goal for MBE contract participation be established biennially through the regulatory process under the Administrative Procedure Act. The biennial statewide MBE goal is established by the Special Secretary for the Governor's Office of Small, Minority, and Women Business Affairs (GOMA), in consultation with the Secretary of Transportation and the Attorney General. In a year in which there is a delay in establishing the overall goal, the previous year's goal applies. The Special Secretary is also required to establish biennial guidelines for State procurement units to consider in deciding whether to establish subgoals for different minority groups recognized in statute. In a year in which there is a delay in issuing the guidelines, the previous year's guidelines apply.

In August 2013, GOMA announced a new statewide goal of 29% MBE participation that applied to fiscal 2014 and 2015; as no new goal has been established, the 29% goal remains in effect for fiscal 2019. GOMA issued subgoal guidelines in July 2011, summarized in **Exhibit 1**, which are also still in effect. The guidelines state that subgoals may be used only when the overall MBE goal for a contract is greater than or equal to the sum of all recommended subgoals for the appropriate industry, plus two. In June 2014, new regulations took effect allowing MBE prime contractors to count their own work for up to 50% of a contract's MBE goal and up to 100% of any contract subgoal. Previously, certified MBE prime contractors could not count their own participation toward any goal or subgoal on an individual contract, but their participation was counted toward the State's MBE goal.

There are no penalties for agencies that fail to reach the statewide target. Instead, agencies are required to use race-neutral strategies to encourage greater MBE participation in State procurements.

History and Rationale of the Minority Business Enterprise Program

In 1989, the U.S. Supreme Court held in the *City of Richmond v. J.A. Croson Co.* that state or local MBE programs using race-based classifications are subject to strict scrutiny under the equal protection clause of the Fourteenth Amendment to the U.S. Constitution. In addition, the ruling held that an MBE program must demonstrate clear evidence that the program is narrowly tailored to address actual disparities in the marketplace for the jurisdiction that operates the program. As a result, prior to each reauthorization of the State's MBE program, the State conducts a disparity study to determine whether there is continued evidence that MBEs are underutilized in State contracting.

The most recent disparity study was completed in 2017 and serves as the basis for the most recent reauthorization of the MBE program. It found continued and ongoing disparities in the overall annual wages, business earnings, and rates of business formation between nonminority males and minorities and women in Maryland. For instance, average annual wages for African Americans (both men and women) were 37% lower than for comparable nonminority males; average annual wages for nonminority women were 33% lower than for comparable nonminority males. It also found continued disparities in the use of MBEs by the State compared to their availability in the marketplace to perform work in designated categories of work. For instance, African American-owned construction businesses were paid 5.1% of State construction contract dollars, but they made up 10.3% of the construction sector in the relevant State marketplace. Nonminority women-owned construction businesses were paid 7.5% of State construction contract dollars but made up 13.7% of the construction sector. According to the analysis, these differences were large and statistically significant.

The MBE program is scheduled to terminate July 1, 2022; it has been reauthorized eight times since 1990, the latest by Chapter 340 of 2017. **Exhibit 2** provides MBE participation rates for major Executive Branch agencies based on contract awards made during fiscal 2017, the most recent year for which data is available.

Requirements for Minority Business Enterprise Certification

An MBE is a legal entity, other than a joint venture, that is:

- organized to engage in commercial transactions;
- at least 51% owned and controlled by one or more individuals who are socially and economically disadvantaged; and
- managed by, and the daily business operations of which are controlled by, one or more of the socially and economically disadvantaged individuals who own it.

A socially and economically disadvantaged individual is defined as a citizen or legal U.S. resident who is African American, Native American, Asian, Hispanic, physically or mentally disabled, a woman, or otherwise found by the State's MBE certification agency to be socially and economically disadvantaged. An MBE owned by a woman who is also a member of an ethnic or racial minority group is certified as either owned by a woman or owned by a racial or ethnic minority but not both. The Maryland Department of Transportation is the State's MBE certification agency.

A socially disadvantaged individual is someone who has been subject to racial or ethnic prejudice or cultural bias within American society because of his or her membership in a group and without regard to individual qualities. An economically disadvantaged individual is someone who is socially disadvantaged whose ability to compete in the free enterprise system has been impaired due to diminished capital and credit opportunities compared with those who are not socially disadvantaged. An individual with a personal net worth in excess of \$1.5 million, adjusted annually for inflation, is not considered economically disadvantaged. The inflation-adjusted limit for calendar 2019 is \$1,749,347.

Organization and Functions of the Legal Department

I. Recommendation:

Approve the proposed update and revisions to: "Commission Practice No. 1-40, Organization and Functions of the Legal Department" set forth in Attachment A.

II. Background:

As a formal matter, the Office of the General Counsel (Legal Department) operates according to the Organizations and Function document contained in Commission Practice No. 1-40 (the "Practice"). In practical terms, this document operates as our department's "charter" – explicating our mission and providing the framework that guides the assignment of roles and responsibilities among the General Counsel, staff attorneys, professional staff and respective teams.

I am proposing to update the Practice, and implement a handful of changes, for several reasons. First, although most provisions remain appropriate, the current version of this Practice has not been updated in almost a decade, and includes other provisions that have become outdated. Second, as we prepare the agency to weather a series of tough budget cycles – including the current one – part of my strategy involves managing cuts with enhanced legal horsepower to create more flexibility. Third, I am gravely concerned that our department's ability to comply with applicable personnel and other administrative demands is being hampered by an organizational structure that simply is too flat. Fourth, I believe our organization will be better served if I am able to devote more time attending to substantive legal issues, and making focused changes to our service delivery methods.

III. Changes

The proposed revision includes an update to the pertinent statutory references and makes a number of stylistic revisions shown in the interlineations detailed in the attachment. Beyond those minor items, the substantive changes proposed for the Practice are highlighted as follows:

• <u>Deputy General Counsel</u>: As revised, the Practice would establish the authority for the General Counsel to appoint a Deputy General Counsel (DGC), and also to delegate appropriate legal and administrative work at that level. My current plan for a new position is to assign a DGC with leadership responsibility for both land use teams, as well as taking principal responsibility for our administrative program. The collateral impact of this change will be to free your General Counsel to devote more time that is needed with our corporate compliance, transactional and litigation work initiatives. With approval, a final organizational structure and reporting lines of authority will be developed after the General Counsel collects additional the input of the senior legal staff.

Of course, several factors will ultimately drive the final budget impact of making this change. Even so, and notwithstanding the FY 20 funding reductions expected for the Montgomery County Administrative Fund, our commitment in the short term is to accomplish this change: (1) on a budget-neutral basis; and (2) with an equal or better (than FY 19) service level for all OGC clients. Over the long term, I am convinced the change will improve overall service delivery and, equally important, improve the overall work experience for other Commission lawyers as well.

- New Business Units. The Practice includes references to several new business units that have evolved since the last revision. Specifically, the language is modified to acknowledge the General Counsel's role in advising the Audit Committee, Inspector General, OPEB Trust.
- Forest Conservation Enforcement: The Practice would also reflect the current reality whereby forest conservation enforcement cases are prosecuted by the Montgomery County Land Use Team. This assignment appropriately manages due process considerations for these civil penalty cases by maintaining a firewall among the MRO legal staff.
- Reporting Relationships: The Practice would also eliminate the mandatory organization chart. As indicated above, a final organizational structure with reporting lines will be developed with input after approval. As it has with other business units, Commissioners will have the regular opportunity to review the Legal Department's structure during the annual budget cycle.

IV. Conclusion.

For these reasons, I recommend and request approval of the proposed Practice. Upon its adoption, I intend to keep the Commission well informed of any consequential changes as they are implemented. Please do not hesitate to call me if you have any questions in advance of the Commission meeting.

[CERTIFICATION OF ADOPTION]

AUTHORITY

Annotated Code of Maryland, Article 28 at §2-106 Land Use Art. at § 15-109(a), and Business Occupations and Professions Article at § 10-101 et seq.

MISSION AND PRIMARY EMPHASIS The mission of the Office of the General Counsel (Legal Department) is to provide cost-effective legal advice and representation of the highest quality to the Maryland-National Capital Park and Planning Commission as a corporate entity. Our attorneys place their primary emphasis on providing proactive counsel, advice and early intervention to support decision makers with a clear picture of all their lawful options.

ORGANIZATION

The Legal Department is headed by the General Counsel, appointed by the Commission, who reports to, is directed by, and serves at the pleasure of the Commission. Ordinary supervision of the General Counsel, including negotiation of the terms and conditions of employment upon appointment, is delegated jointly to the Chairman and Vice-Chairman of the Commission.

The Legal Department currently is organized into five specialized legal practice teams, and one department-wide administrative support team.

The five legal practice teams are enumerated as follows:

- 1. The Litigation and Employment Law Team;
- 2. The Prince George's County Land Use Team;
- 3. The Montgomery County Land Use Team;
- 4. The Transactions Practice Team; and
- 5. The Legislative Management Team.

The General Counsel may designate one attorney as a Deputy General Counsel with such delegated duties and responsibilities as may be authorized under this Practice.

The General Counsel may <u>also</u> designate one attorney as a Team Leader with day-to-day responsibility for general supervision and leadership for each Team. Designated Team Leaders report directly to the General Counsel <u>or</u>, <u>if delegated</u>, <u>to the Deputy General Counsel</u>. Other attorneys, law clerks, paralegals and legal professionals assigned to support each team report directly to their respective Team Leader, <u>or the Deputy General Counsel</u>, <u>as the applicable case may be</u>.

Each Team Leader, <u>the Deputy General Counsel</u>, and every attorney who is a member of the Legal Department, will ensure that Commission clients are directed to the team most appropriate to address specific legal needs, and must maintain good and prompt cross-collaboration among all other teams whenever appropriate.

Administrative support for the Legal Department is assigned by the General Counsel or Deputy General Counsel to a Chief Departmental Administrator business manager who reports directly to the General Counsel or Deputy General Counsel. The Chief Departmental Administrator business manager oversees departmental compliance with the Commission's internal operating policies and procedures, including budget, finance, cash management, personnel, procurement, and other operating policies.

The Chief Departmental Administrator <u>business manager</u> also supervises the Legal Department's administrative support staff under a matrix management program that incorporates job performance information provided by attorneys and utilizes department-wide internal procedures.

The General Counsel should allocate and assign legal staff to provide services to Commission operating units and from multiple on-site office locations, subject to available space, funding and other reasonable considerations.

Organization Chart included as Attachment A.

FUNCTIONS

A. General Counsel

As the Commission's chief legal officer, the General Counsel performs the following duties:

- 1. Administers, supervises, organizes, coordinates, and directs the activities and staff of the Legal Department, and manages the disposition of legal matters including, but not limited to:
 - a. Representing the Commission in all civil and administrative proceedings to which the Commission is a party, retaining outside legal counsel as necessary and appropriate;
 - b. Carrying out condemnation proceedings pertaining to land for parks and open space under the power of eminent domain; acquisition of land sales activities of surplus land, with the exception of title and settlement work which may be handled by outside attorneys; and associated matters such as eviction proceedings;
 - c. Rendering of written and oral opinions, and recommending disposition of all requests for legal assistance to the Commission, Planning Boards, Executive Committee, Finance Committee, Audit Committee, department heads, and staff on questions of law involving the administration and exercise of the Commission's statutory and regulatory functions, jurisdiction, and power;
 - d. Drafting and/or approving for legal sufficiency contracts, deeds, leases, resolutions, and other documents to which the Commission is a party;
 - e. Preparing and reviewing state and local legislative matters, including testimony and attendance at work sessions;
 - f. analyzing, drafting, and redrafting of local ordinances and laws as requested by Commission staff and Planning Boards;
 - g. Maintaining intergovernmental liaison with members of the Maryland General Assembly and with other governmental bodies as directed by the Commission or Planning Boards;

- h. Developing appropriate performance measures, internal operating procedures, and appropriate management information tools to monitor Legal Department work performance; and,
- i. Developing performance tracking reports and sharing departmental performance information as determined in his/her sole discretion to be appropriate and consistent with preserving attorney-client privilege.
- 2. Provides legal counsel and advice to Commission management, the Board of Trustees of the Employees' Retirement System, other employee benefit boards of trustees, Inspector General, the Audit Committee and to other committees of the Commission, as required.
- 3. Represents Commission management in proceedings before the Merit System Board, LEOBR Trial Boards, and other internal or external adjudicatory tribunals as required.
- 4. Provides legal advice to management and staff on other matters, including equal employment opportunity (affirmative action) and human relations matters, and legal aspects of fiscal and budgetary matters.

B. **Deputy General Counsel**

The General Counsel may delegate to the Deputy General Counsel any lawful authority or responsibility of the office as the General Counsel may prescribe from time to time in writing as determined within his or her reasonable discretion. The Deputy General Counsel shall serve in the capacity as the Acting General Counsel in the event the General Counsel is incapacitated from discharging the duties of that office as a result of an extended absence or period of disability.

C. Teams

The General Counsel hereby delegates certain responsibilities to the respective legal teams provided in this Practice as follows:

1. **The Litigation and Employment Law Team.** The Litigation and Employment Law Team is assigned primary responsibility for providing legal representation in the

following matters:

- a. The prosecution and defense of civil trial and appellate litigation and ancillary civil court proceedings (not including actions for <u>declaratory relief or</u> judicial review of administrative decisions made by the Commission in land use cases);
- All Commission personnel functions and related management issues, including compliance with the Merit System Rules and Regulations, employment disputes, personnel records, practices and policies, employee benefit and retirement programs, collective bargaining activities, application of Law Enforcement Officers Bill of Rights (LEOBR), workers compensation claims, unemployment insurance claims, employment discrimination claims and similar matters;
- c. The prosecution and defense of administrative proceedings held before any internal, state or federal tribunal or similar authority convened to investigate or adjudicate employment-related disputes, including the Commission's Merit System Board, LEOBR trial boards, the Equal Employment Opportunity Commission, the Maryland Commission on Human Relations, any authorized arbitration tribunal, and the Maryland Division of Unemployment Insurance;
- d. The prosecution of civil citations and other litigation to enforce the Montgomery County forest conservation ordinance and development approval regulations in proceedings before the Montgomery County Planning Board, other administrative bodies or officers or a court of competent jurisdiction;
- d. Advice, legal support, and coordination necessary to comply with or contest any subpoena seeking the testimony of a Commission employee or official, or any inquiry or subpoena issued in connection with a criminal investigation or external audit request;
- e. Advice and legal support for the Commission's

Employees' Retirement System;

- f. Advice and legal support for the Commission's safety, risk management and self-insurance functions, including evaluating liability issues throughout all Commission operations and activities;
- g. Training to support the identification of liability issues as a component of reviewing documents for legal sufficiency;
- h. Advice and legal support for the Commission's payroll and internal audit functions;
- i. Advice and legal support for the Commission's Park Police functions, including inter-jurisdictional mutual aid agreements;
- j. Advice and legal support for the development and promulgation of Commission-wide practices, policies, regulations and administrative procedures;
- k. Advice, legal support, and coordination necessary to comply with or contest any request made under the Maryland Public Information Act that is related principally to a substantive matter assigned to the Team pursuant to this Practice;
- 1. Advice, legal support and preparation of any employment agreement, settlement agreement or document effectuating a liability release; and,
- m. The management of outside legal counsel retained to represent the Commission in any substantive matter assigned to the Team pursuant to this Practice, including any outside counsel retained under the aegis of the self-insurance fund.
- 2. **The Prince George's County Land Use Team.** The Prince George's County Land Use Team is assigned primary responsibility for providing legal representation in the following matters:
 - a. Advice and legal support for the Prince George's County Planning Board and Planning Department in

executing any administrative, quasi-legislative, or quasi-judicial function in a land use matter arising under the provisions of Maryland law or the local laws of Prince George's County, Maryland;

- b. Advice, legal support and timely legislative advocacy on behalf of the Prince George's County Planning Board and Planning Department appropriate to influence amendments proposed to local laws of Prince George's County that relate to the regulation of land use or the Commission's land use functions;
- c. The prosecution and defense of lower court actions and related appellate litigation involving **declaratory relief or** judicial review of administrative decisions made by the Prince George's County Planning Board and Planning Department in land use cases;
- d. Preparation of documents appropriate to support the regulatory activities of the Prince George's County Planning Board and Planning Department, including resolutions, deeds of dedication, terms of covenants and restrictive easements, and conditions of regulatory approval;
- e. Advice, legal support, and coordination necessary to comply with or contest any request made under the Maryland Public Information Act that is related principally to a substantive matter assigned to the Team pursuant to this Practice; and,
- f. The management of outside legal counsel retained to represent the Commission in any substantive matter assigned to the Team pursuant to this Practice.
- 3. **The Montgomery County Land Use Team.** The Montgomery County Land Use Team is assigned primary responsibility for providing legal representation in the following matters:
 - a. Advice and legal support for the Montgomery County Planning Board and Planning Department in executing any administrative, quasi-legislative, or quasi-judicial function in a land use matter arising under the

provisions of Maryland law or the local laws of Montgomery County, Maryland;

- b. Advice, legal support and timely legislative advocacy on behalf of the Montgomery County Planning Board and Planning Department appropriate to influence amendments proposed to local laws of Montgomery County that relate to the regulation of land use or the Commission's land use functions;
- c. The prosecution of civil citations and other litigation to enforce the Montgomery County forest conservation ordinance and development approval regulations in proceedings before the Montgomery County Planning Board, other administrative bodies or officers or a court of competent jurisdiction;
- d. The prosecution and defense of lower court actions and related appellate litigation involving <u>declaratory</u> <u>relief or</u> judicial review of administrative decisions made by the Montgomery County Planning Board and Planning Department in land use cases;
- e. Preparation of documents appropriate to support the regulatory activities of the Montgomery County Planning Board and Planning Department, including resolutions, deeds of dedication, terms of covenants and restrictive easements, and conditions of regulatory approval;
- f. Advice, legal support, and coordination necessary to comply with or contest any request made under the Maryland Public Information Act that is related principally to a substantive matter assigned to the Team pursuant to this Practice; and,
- g. The management of outside legal counsel retained to represent the Commission in any substantive matter assigned to the Team pursuant to this Practice.
- 4. **The Transactions Practice Team.** The Transactions Practice Team is assigned primary responsibility for providing legal

representation in the following matters:

- a. Advice, legal support and preparation of legal documents for the effective transaction of public business and related commercial arrangements between the Commission and private third parties. Examples of legal documents assigned to this Team include: purchase agreements, instruments covered under the Uniform Commercial Code, public-private partnership agreements, real estate and chattel leases, concession agreements, donation agreements, development agreements, and technology licensing agreements;
- b. Advice, legal support and preparation of legal documents for the effective transaction of public business between the Commission and other entities of government;
- c. The Team is not assigned primary responsibility for Commission agreements relating to settlements, employment, or police mutual aid;
- d. The prosecution and defense of administrative proceedings held before any internal, state or federal tribunal or similar authority convened to adjudicate a contract or procurement dispute;
- e. Promulgation of form documents appropriate to support the regulatory activities of the Commission, including form deeds of dedication, standard terms of covenants and restrictive easements, recreational facilities agreements, and conditions of approval relating to rights of the Commission in real property;
- f. Advice and legal support for transactions involving the Commission's information and communications technology functions;
- g. Advice and legal support for the Commission's procurement, treasury, finance, bond and cash management functions;
- h. Advice, legal support, and coordination necessary to

comply with or contest any request made under the Maryland Public Information Act that is related principally to a substantive matter assigned to the Team pursuant to this Practice; and,

- i. The management of outside legal counsel retained to represent the Commission in any substantive matter assigned to the Team pursuant to this Practice.
- 5. **The Legislative Management Team.** The Legislative Management Team is assigned primary responsibility for providing legal representation in the following matters:
 - a. Advice, legal support and timely legislative advocacy on behalf of the Commission appropriate to influence amendments/proposed laws of the General Assembly and Congress that relate to Commission functions;
 - b. Advice and legal support for the Commission on matters of legislative rules, practices, custom, protocol and procedures;
 - c. Advice, legal support and analysis of legislative enactments and potential impact on Commission operations;
 - d. Coordination and support of Commission staff assigned to monitor State and Federal legislative activities (Legislative Management Team);
 - e. Advice, legal support, and coordination necessary to comply with or contest any request made under the Maryland Public Information Act that is related principally to a substantive matter assigned to the Team pursuant to this Practice; and,
 - f. The management of outside legal counsel or lobbying professionals retained to represent the Commission in any substantive matter assigned to the Team pursuant to this Practice.

PROHIBITIONS

No attorney, employee, legal entity or other person (including outside counsel) may **engage in the** practice **of** law on any matter relating to Commission business without the approval by the General Counsel (or his designee as authorized in writing). For this

purpose, the term "practice **of** law" has the meaning provided from time to time under § 10-101(h) of the Business Occupations and Professions Article of the Maryland Annotated Code.

The General Counsel or any member of the Legal Department shall not provide legal assistance or representation to any Commission employee on any legal matter which is not within the scope of **their such employee's** Commission employment, official duties and responsibilities, unless the Commission or a person authorized by the Commission specifically directs that such assistance or representation be given.
